- Outcomes
 - Alternative fuels can be a win-win solution for reducing aviation's dependence on fossil fuels and a key element to help reduce the impact of aviation on climate change.
 - Alternative fuels should be part of a comprehensive aviation energy strategy that includes technological, operational and market-based measures.
