Accessibility today, 25+ years of reform & dev.

Aviation accessibility regulation is complex and doesn't serve its intended audience. Fundamental experience gaps remain!

Current state of accessibility

- ICAO Annex 9, Doc 9984, A41-15, LTSP 2026-50
- Compliance complexities, sometimes conflicting (example: separate accessibility and safety policy agendas and regulatory frameworks)
- Experience gaps persist and grow

Barriers persist but opportunities remain to do better, and more

- Structure: legal framework, global standard, regulatory innovation, investments
- Infrastructure: airport design, cabin design, digital design (+IFE)
- Culture: mindset, language, information, signage, awareness

Example experience gaps

Information, guidance gap

the struggle to find reliable, trusted information or access to expert guidance

Autonomy gap

the inability to travel independently and the need for assistance to navigate barriers

Travel time gap

the additional time needed for planning journeys including extra waiting, delays or slowdown


Comfort, consistency gap

the constant need to familiarize with products, transport services, spaces, equipment, and facilities

Macro socio-economics

25% of the global population¹ can benefit from accessibility and inclusive design. By 2050, 4 billion² passengers with accessibility requirements will travel.
