This Committee brings together key actors—immigration, customs, health, security, and aviation stakeholders—to ensure effective coordination and readiness to address emerging challenges, including pandemics and security risks.

Moreover, in line with the spirit of the Declaration, Kenya has enhanced its international cooperation, aligning national strategies with ICAO guidance and regional frameworks. We remain an active participant in the ICAO Facilitation Panel and its Working Groups, where we continue to exchange insights and contribute to global best practices.

Innovation in Facilitation: Digital Transformation

Turning to **Agenda Item 11**, Kenya recognizes the crucial role of digital innovation in modern facilitation. The rollout of biometric e-passports with a 10-year validity period marks a shift from traditional passports to secure, digital credentials. In 2022, Kenya joined the ICAO Public Key Directory (PKD) as the 89th Member State, reinforcing our commitment to globally trusted and interoperable document verification.

In conclusion, Mr. President, Kenya remains fully committed to working with ICAO and all Member States to promote innovative, inclusive, and future-ready air transport facilitation.
