Specific challenges of the Asia-Pacific region will be considered and solutions leveraging regional cooperation brought forward. Discussions will explore innovative solutions for optimizing the issuance and inspection of travel documents in line with ICAO Doc 9303 specifications. PASSENGER DATA SYSTEMS: API, PNR &amp; THE UN CT TRAVEL PROGRAMME</b></p> <p>Panelists will examine the Implementation of Advance Passenger Information (API) and Passenger Name Record (PNR) data systems in line with ICAO Standards and Recommended Practices and global best practices. The need for cooperation between State authorities and private sector entities will be brought forward. Discussions will also emphasize the need for greater consistency in the deployment of passenger data systems, with a focus on leveraging National Air Transport Facilitation Committees (NATFCs) to enhance coordination and support for API and PNR development.
