

ICAO GLOBAL SYMPOSIUM ON AIR TRANSPORT LIBERALIZATION

(Dubai, United Arab Emirates, 18-19 September 2006)

BULLETIN NO. 2

Further to Bulletin No. 1 of the Symposium (dated 1 March 2006) issued to your Government/Organization, this Bulletin No. 2 is to provide you with an update of the arrangements for participants attending the Symposium. 1. **Updated Programme**

1.1 An updated tentative programme of the Symposium is attached, which includes names of confirmed speakers who will be addressing the meeting. Future updates of the Symposium programme will be posted at the meeting website.

2. **Registration of Delegates**

- 2.1 All participants are reminded to complete their registration as early as possible. Preregistration is strongly encouraged.
- As specified in Bulletin No. 1, *delegates nominated by ICAO Contracting States and invited organizations* should send their nominations (including name, position, contact information) to ICAO by letter or fax (+1 514 954 6744), or by e-mail (<u>Dubai2006@icao.int</u>). Once this notification has been done, there are no further additional registration requirements. ICAO should be notified of any changes in nomination(s) as soon as possible.
- 2.3. For *all other participants*, who will be charged a moderate fee of USD\$200 for attendance, pre-registration is encouraged, and can easily be done online at the meeting website by following the specified instructions.

3. Hotel Booking and Entry Visa

- 3.1 All participants are reminded to make their hotel reservations in Dubai as early as possible. Detailed information about the suggested hotels for the Symposium delegates and procedures for hotel bookings are provided in both Bulletin No. 1 and the Symposium website.
