2.3 Attendance and List of Delegates

2.3.1 The 10th Statistics Division Meeting welcomed 131 delegates from 50 ICAO Member States and six organizations with observer status to ICAO. A List of Delegates can be expected to be distributed on Thursday, 26 November 2009, in front of Document Distribution.

3. PROCEEDINGS ON 25 NOVEMBER 2009

3.1 Morning session

3.1.1 Deliberations of Agenda item 8 — Civil Aircraft on Register and Data Collection on Equipages and Ground Equipment took place on the basis of the following working papers, listed in the order in which they were presented by the Secretariat: WP/18 — Civil Aircraft on Register, and WP/19 — Inventory of Air Navigation Equipment on Board Aircraft and on the Ground.

3.1.2 The EUROCONTROL Representative gave a demonstration on the EUROCONTROL PRISME Fleet Database. While the Representative of Saudi Arabia gave a presentation on a sample analysis of aircraft movement data.

3.1.3 Deliberations of Agenda item 9 — Civilian Licensed Personnel Data were carried out based on WP/20 — New Data Collection for Civil Personnel Licenses and Training.

3.1.4 Deliberations of Agenda item 10 — Fuel Consumption by Commercial Air Carriers were carried out on the basis of: WP/21 — Proposal for New Data Collection on Fuel Consumption by Commercial Air Carriers.

3.2 Afternoon session

3.2.1 The Division reviewed and adopted unanimously the Draft Reports on Agenda Item 2, 3, 4, 5, 6 and 7.

3.2.2 Deliberations of Agenda item 11: Aircraft Accidents and Safety Analysis were carried on the basis of WP/22 — Reference and Use of the Integrated Statistical Database (ISDB) for Safety Data Analyses, and WP/23 — Aircraft Accidents and Serious Incidents.

3.2.3 A summary of the discussions will be reflected in the draft report, covering the aforementioned agenda items, to be considered by the Division on Thursday 26 November 2009.
