


#### **IOM's Vision**

#### Orderly Migration in the Interest of Everyone



Migration that contributes to the development of the individual and the society as a whole



# Why is there a need for an international migration agency?

- There are an estimated 191 million migrants worldwide in 2005,
- There are roughly 30 to 40 million unauthorized migrants worldwide
- In 2006, there were 24.5 million internally displaced persons (IDPs) in at least 52 countries as a result of conflict
- In 2006, remittance flows are estimated to have exceeded USD 276 billion worldwide, USD 206 billion of which went to developing countries.

### What is IOM ?

- IOM is an intergovernmental international organization founded in 1951
- There are currently 122 Member States
- 400 offices in over 120 countries
- 5,600 staff working on over 1700 projects
- Annual expenditure of USD 783.8 million (2007)

### Technical Cooperation on Migration

The activities of IOM's Technical Cooperation on Migration (TCM) Division help governments equip themselves with the necessary policy, legislation, administrative structures, operational systems and human resource base needed to tackle diverse migration problems.

### Technical Cooperation projects

- Most IOM TC projects begin with a detailed Migration and Border Management Assessment
- The Assessment becomes the basis for a multi-year technical cooperation project
- We currently have USD 80 million in TC projects worldwide

In most case the recommendations have been adopted as medium term plans of action with accompanying technical cooperation projects.
