Provide a full and comprehensive perspective on the kinds of factors to be considered and the nature of sources that should be consulted in order to develop a complete perspective for entitlement and document adjudication judgements and decisions.

Include documents and bring the attention all of the other accompanying ways in which the Evidence of Identity considerations should be viewed.



TR intended to be used by:

- Individuals engaged in the full spectrum of identity management;
- The staff of issuing authorities, inspection and police authorities, and immigration authorities as well as those engaged in other document entitlement endeavours
 - This include issuers of driving licenses, cards of national identity, voter registration et al.

Especially designed to reach to those involved in civil registry and other vital records-related database activities, to encompass the very important and pivotal role performed by those engaged in numerous related entitlement functions related to birth and death records, recording of marriages and divorces, and other civil registry matters.



Scope

Therefore, the scope of the TR is to provide States with guidance on this Evidence of Identity foundation in order to properly and uniquely identify individuals for the purposes of issuing trusted travel documents and contribute to overall security worldwide.



Scope

- ➤ IS NOT about the full spectrum of Identity

 Management but these components for

 establishing identity:
 - evidence that the claimed identity is valid i.e. that the person was born and, if so, that the owner of that identity is still alive;
 - evidence that the presenter links to the claimed identity;
 - evidence that the presenter uses the claimed identity

Scope

- Means used to verify these components include civil registration, social footprint, foundation (source) documents
- Includes the use of technological and electronic tools to uniquely verify the TD bearer's identity, such as PKI, PKD, biometric algorithms et al.

Issuance of Three-Letters Codes to Intergovernmental International Organizations

- The ICAO Secretariat issues unique threeletter codes to intergovernmental international organizations.
- Scope is limited to ascertain the criteria for issuing three-letter codes to these intergovernmental international organizations.

- International intergovernmental organizations may issue non-compliant TD;
- Need to develop policy guidelines and criteria.



> Criteria:

- Inter-governmental international organization, regulated by the Vienna Convention (1969)
- Established by States by treaty
- Treaty in force and valid
- Provision for issuing accepted TD by treaty or protocols
- Governing bodies
- Applicant organization's responsibility

- ➤ Action by the TAG/MRTD:
 - Consider and provide advice on this matter and the criteria outlined for further consideration by the Secretariat and the ATC.
