This is a special year for us in Hong Kong as it is the **20**<sup>th</sup> **Anniversary** of the establishment of the Hong Kong Special Administrative Region In China. We have the honour to include this ICAO TRIP Seminar as an event to celebrate our 20<sup>th</sup> Anniversary of the Hong Kong Special Administrative Region and have the 20th Anniversary logo displayed on stage and souvenirs.

Hong Kong, China is geographically located in the heart of Asia and we are at the cross road between East and West. Half of the world's population can be reached within just five hours. At present, around 110 airlines operate from the Hong Kong International Airport. The Civil Aviation Department handles over 2,000 flights everyday with some 1,100 flights landing and taking off at the Hong Kong International Airport and around 900 flights overflying Hong Kong. Hong Kong China is connected to more than 200 destinations around the world (including 42 destinations in the Mainland China).

Our airport has been the world's busiest cargo hub for 7 consecutive years, and is the third busiest international passenger airport. Last year, the airport handled over 70 million passengers and 4.5 million tonnes of cargo.
