**Vijay Poonoosamy - *Master of Ceremony***

*Singapore-based Director International and Public Affairs of QI Group*

Vijay Poonoosamy of Mauritius is the Singapore-based Director International and Public Affairs of QI Group, an Executive Board Member and Chairman of the Aviation Group of World Tourism Network, an Honorary Member of the Hermes Air Transport Organisation and a member of the Advisory Board of the World Tourism Forum Lucerne.

Vijay was the Managing Director of Air Mauritius, the Executive Chairman of Airports of Mauritius and the Vice President International & Public Affairs of the Etihad Aviation Group. He was also Chairman of the 4th ICAO Worldwide Air Transport Conference and of the Air Transport Committee of the African Civil Aviation Commission.



**Dr. Fang Liu**

*Secretary General of the International Civil Aviation Organization (ICAO)*

Dr. Fang Liu was first appointed for a three-year term starting August 2015, and reappointed in 2018 for a consecutive three-year term until July 2021.

Over the course of the preceding twenty years, Dr. Liu served for eight years as the Organization's director of administration. She also served the General Administration of Civil Aviation of China (CAAC), where she held the posts of Legal Counsel, Deputy Director, Director and Deputy Director General, International Affairs and Cooperation. She was responsible for China's international air transport policy and regulations, bilateral and multilateral relations with external organizations including ICAO, World Trade Organization, Asia-Pacific Economic Cooperation, European Union, and Association of Southeast Asian Nations. Dr. Liu was also chief negotiator for the Chinese government for bilateral and multilateral air transport agreements with foreign countries.



## **Michèle Coninsx**

*Assistant Secretary-General and Executive Director, Counter-Terrorism Committee Executive Directorate (CTED)*

Michèle Coninsx was appointed Assistant Secretary-General (ASG) and Executive Director of the Counter-Terrorism Committee Executive Directorate (CTED) by UN Secretary-General António Guterres in 2017.

Ms. Coninsx previously served as President of Eurojust – the European Union agency tasked with dealing with judicial cooperation in criminal matters, after having served as its Vice-President. In addition, Ms Coninsx was the National Member for Belgium at Eurojust, and Chair of Eurojust’s Counter-Terrorism Team. Before joining Eurojust, Ms Coninsx was a Federal Prosecutor (Magistrat Fédéral) in Belgium, dealing with terrorism and organised crime.

She holds a Belgian noble title of Baroness, as well as the title of Honorary Fellow of Law and Criminology at the University of Brussels (Vrije Universiteit Brussel), Visiting Professor in the School of Law at Queen Mary University of London, and in the College of Europe. Ms Coninsx has a Master’s Degree in Law, a Master’s Degree in Criminology, and is a specialist in Air Law and Aviation Security (UK-USA). She has also served as an expert in aviation security for the International Civil Aviation Organization (ICAO).

**Dion Chamberlain - *Moderator***

*Manager Product Development, Identity Services – Department of Internal Affairs, New Zealand*

Dion Chamberlain is the Manager Product of Development for Identity at the Department of Internal Affairs (DIA), where he has worked since 2003 in roles spanning Passports, Citizenship, Digital Identity and Civil Registration.

Dion is responsible for the development of new identity products for New Zealanders – a function that includes systems thinking and user-based design to put customer at the centre of development. His role also oversees business intelligence and innovation, new product and service development, information sharing services, and working in public and private sector partnerships. He has been closely involved in the development and delivery of highly successful initiatives, including RealMe digital identity, the introduction of e-Passports, the use of facial recognition technology in automated issuance processes, and the world's first fully online Passport renewal service.

Dion is currently the Secretary of the International Civil Aviation Organisation (ICAO) Implementation and Capacity Building Working Group (ICBWG), which is focussed on improving capability of travel document issuance authorities and border control agencies globally. He is also the Chair of the ICAO New Technologies Working Group Policy Sub-Group for the Development of the Digital Travel Credential.



**Mohamed Rahma**  
*Director, Air Transport Bureau, ICAO*

Mr. Mohamed Khalifa Rahma assumed his position as Director, Air Transport Bureau, of the International Civil Aviation Organization (ICAO) in April 2020. Before his appointment, Mr. Rahma was the Regional Director of the ICAO Middle East Regional Office since March 2016. The current work portfolio of Mr. Rahma covers a wide range of global aviation domain including Air Transport, Aviation Security and Facilitation and Environmental protection. He is currently the Secretary of the Council Aviation Recovery Task Force (CART).

During his tenure in ICAO Middle East Office, he was instrumental in strengthening regional and inter-regional collaboration in aviation industry. This effort included enhancing risk awareness and response, promoting technologies while fostering new innovations, and improving oversight and quality assurance. Mr. Rahma continues to significantly increase cooperation among member States, international and Regional organizations.

Prior to Joining ICAO, Mr. Rahma was the Undersecretary of International and Internal Affairs at the Ministry of Civil Aviation of Egypt and previously the advisor to the Egyptian Minister of Civil Aviation. During his tenure at the Egyptian government, Mr. Rahma played a substantial role and led influential projects that actively supported and enhanced aviation capacity and efficiency in Egypt. He developed cooperative relationships with government bodies and investors while paving the way for future business partnerships and opportunities.

Mr. Rahma was a board member of various companies including Cairo Airport Company, Aerotel Company and EMAC Aqaba Company and chaired many strategic committees under the umbrella of the Ministry of Civil Aviation for special projects. He led and participated in many high level national and regional committees.

Matthias Oel is Director for Schengen, Borders and Innovation in DG Migration and Home Affairs, European Commission.

Before assuming this position in May 2017 he was Director for Migration and Security Funds in the same DG from January 2016, Head of Unit for Asylum (as of April 2012) and Special Adviser in the Cabinet of the President of the European Council Herman Van Rompuy (as of January 2010).

Matthias Oel started his career in the German Federal Ministry for Economics and joined the European Commission for the first time in 1995 as Seconded National Expert in the Cabinet of Commissioner Dr. Monika Wulf-Mathies (Regional Policy). In 1997 he moved to the Permanent Representation of Germany to the EU where he worked as Counselor for Industry and Regional Policy during the German EU-Presidency 1999. Afterwards he became a Commission official and worked as Parliament and Council coordinator and Assistant to the Director General for Personnel and Administration. From 2004 to 2006 he was Member of the Cabinet of Vice-President Günter Verheugen mainly covering the Industry Policy dossier.

**Zoritsa Urosevic,**

*World Tourism Organization (UNWTO) Representative to the UN in Geneva*

Ms Urosevic is currently the UNWTO Special Representative to the United Nations in Geneva and New York (a.i), and Director of the Institutional Relations and Partnerships Department having joined the World Tourism Organization in 2006. The department provides policy advice for external relations, strategic partnerships and financing for development to the Secretariat, including the integration of the 2030 Agenda and the UN Reform in the organization's strategic work and delivery. Urosevic is a member of UNWTO's Global Tourism Crisis Committee (GTCC), strengthening UNWTO and partners response to the current COVID-19 crisis, with a key focus on collaboration with WHO, ICAO and other UN entities and International Organizations (IOs), as well as forging a strategic delivery with International Finance Institutions for recovery and resilience building. She received the SIA Women in Biometrics Award in 2017 for her contribution to the biometrics community in promoting the responsible and ethical use of biometrics. The award is dedicated to recognising innovative women creating a more secure world by guiding the biometrics technology market. She has spoken at many of the Biometrics Institute events but also at important meetings of the United Nations, Interpol, OSCE, ICAO and Frontex to name a few. Isabelle holds a Master of Arts in English Literature, Business and the Arts from the Johann-Wolfgang-Goethe University in Frankfurt Main, Germany.

*Chief-Inspector of Police, Head of Administrative Detention Centre (Mayotte),  
French National Police*

Mr. BEZZINA, 44, joined the French National Police Force in 2001 as Senior Police Officer.

Mr. Bezzina has started as night duty Inspector in a main Police station in the east of France. Then between 2005 and 2008, he was commander of immigration investigation unit (Border Police) in French Guyana, a French territory located in South America, next to the Brazil. **Jürgen Stock** - *Moderator*  
*Secretary-General, INTERPOL*

Jürgen Stock was appointed as Secretary General of INTERPOL in November 2014 and was re-appointed in October 2019 to serve a second five-year term. He has more than 40 years of policing experience.

Secretary General Stock has initiated changes in four key areas: to improve core business services to police, establish strong partnerships, embrace innovation, and strengthen governance structures and mechanisms.

He established three global programmes to guide all INTERPOL's policing activities: Counter-Terrorism, Organized and Emerging Crime, and Cybercrime. Since 2014, Secretary General Stock has also overseen the creation of a specialized task force to review Red Notice requests, a new Statute for the Commission for the Control of INTERPOL's Files, a review of the legal framework around the Organization's governing bodies, and a change in the funding model to focus more on public sector contributions.



## **Vladimir Voronkov**

*Under-Secretary-General, Office of Counter-Terrorism (UN OCT)*

Mr. Vladimir Voronkov was appointed Under-Secretary-General of the United Nations Office of Counter-Terrorism on 21 June 2017, established by General Assembly resolution 71/291.

Mr. Voronkov brings to the position more than 30 years of experience within the Foreign Service of the Russian Federation, working primarily on United Nations affairs, with responsibilities ranging from public diplomacy and social and economic development issues to intergovernmental affairs.

Prior to his appointment, he was Ambassador and Permanent Representative of the Russian Federation to the International Organizations in Vienna. Under his leadership, the Permanent Mission launched several flagship projects with the United Nations Office on Drugs and Crimes (UNODC) and developed successful collaborations with the UNODC Antiterrorist Branch. Mr. Voronkov also served on the Board of Governors of the International Atomic Energy Agency (IAEA), during which time he led several delegations of the Russian Federation to the Commission on Narcotic Drugs and the Commission on Crime Prevention and Criminal Justice.

Prior to serving in Vienna, Mr. Voronkov was Director of the Department of European Cooperation (2008-2011), during which time he served as the Head of the Russian Delegation during the Russia-European Union negotiations on the visa-free regime (2010-2011). **Sylvain Lefoyer - Moderator**

*Deputy Director, Aviation Security and Facilitation, ICAO*


