#### 建议加强全球航空货运保安的路线图

(由澳大利亚、比利时、加拿大、中国、德国、日本、约旦、黎巴嫩、新西兰、俄罗斯联邦、沙特阿拉伯、塞内加尔、新加坡、南非、瑞士、联合王国、美国、国际机场理事会、全球快递协会、国际航空运输协会、国际航空货运协会、万国邮政联盟、世界海关组织提交)

### 执行摘要

为了支持国际民航组织加强航空货运保安的作用,航空保安专家组的航空货运保安(WGACS)工作组已经编制了一份路线图,明确了国际利益攸关方开展的关键活动和为加强全球航空货运保安<sup>1</sup>打击非法干扰威胁的作用。在广泛行动领域确定的举措是指国际民航组织全面的航空保安战略综(ICASS)的有关战略重点领域(请参阅 A38-WP/13 号文件)。

**行动**:请大会批准加强全球航空货运保安的路线图,作为正在进行活动的概述,并同意其须不断更新,以反映最新发展情况。

战略目标:	本工作文件涉及战略目标 B 一《保安》。
财务影响:	无需额外资源。

#### 1. 引言

- 1.1 2010 年 10 月 29 日将简易爆炸装置 (IED) 装入航空货运供应链的阴谋说明了全球航空货运保安系统被恐怖分子所利用的漏洞。这一阴谋强调会员国有必要采取协同行动,通过国际协调、严格执行、统一和实用及不阻碍国际贸易的方式,加强航空货运保安的现有措施。
- 1.2 自 2010 年以来,会员国和航空利益攸关方勤奋工作,对航空货运保安威胁、加强保安管制以减轻这种威胁的最有效途径形成了现代观点。2011 年 4 月组建了由包括来自成员国、世界海关组织、万国邮政联盟和国际航空运输协会、全球快递协会等行业机构的代表组成的航空保安专家组的航空货运保安工作组(WGACS)。
- 1.3 航空保安专家组 2011 年 6 月以来召开过五次会议,通过与航空货运保安工作组、附件 17 工作组、指导材料工作组及关键利益攸关方协作努力加强航空货运保安,包括强化基线保安标准与建议措施(SARPs)。
- 1.4 2012 年 9 月 12 日至 14 日在蒙特利尔举行的国际民航组织航空保安高级别会议,通过并批准了一套航空货邮保安原则,作为国际民航组织和所有利益攸关方采取行动以确保航空货邮供应链保安的基石。此后,国际标准和建议措施《保安 保护国际民用航空免遭非法干扰行为》(国际民用航空公约附件 17)第 13 次修订于 2013 年 7 月 15 日生效,其中主要包括航空货运保安的有关标准与建议措施,以及《航空保安手册》(Doc 8973 号文件)第八版第 1 次修订的相应新的指导材料。
- 1.5 加强全球航空货运保安框架是一个多层面的任务,应该不仅审议常规的监管标准、建议措施和指导,也须强化技术和信息工具。会员国、观察员和关键的利益相关者,单独与合作地不断推动这一个重要机构的工作,通过多种多样的活动加强空运货物的保安成果。这些措施包括完善标准和指导文件、提供培训、提供并参与能力建设、追求协调与统一要求的机会、开发技术、工具和先进的风险评估技术。
- 1.6 虽然初期的工作已经取得了良好效果,但利益攸关方保持参与这一进程甚为重要,进一步加强空运货物的各项保安安排。引入修订的标准和流程之后,今后几个月重点将放在协调实施这些措施。

#### 2. 路线图

- 2.1 汇集这项工作并支持国际民航组织航空保安高级别会议加强空运货物保安的政策方向(参见 A38-WP/12 号文件), 航空货运保安工作组编制了一份加强全球航空货运保安路线图("路线图"), 见附录 A
- 2.2 路线图明确了国际利益攸关方开展的关键活动和为加强全球航空货运保安打击非法干扰威胁的作用。在广泛行动领域确定的举措是指国际民航组织全面的航空保安战略综(ICASS)的有关战略重点领域(请参阅 A38-WP/13 号文件)。路线图还与航空货邮保安的原则保持一致。

- 2.3 路线图的目的是为了:
  - a) 清楚地阐明多个利益攸关方在一个复杂的系统进展的多层面方法;
  - b) 确定国际合作的相互联系、协同效应和机遇;
  - c) 推动了解所有利益攸关方发挥的往往是相互关联的作用与责任;和
  - d) 通过确定活动状况并鼓励远期规划,鼓励这一进程的持续发展势头。
- 2.4 路线图是一个活的文件,将定期审查及更新,以反映进展情况。
- 2.5 请大会批准加强全球航空货运保安的路线图,作为正在进行活动的概述,并同意其须不断更新,以反映最新发展情况。

# APPENDIX ROADMAP TO STRENGTHEN GLOBAL AIR CARGO SECURITY

The Roadmap articulates the key activities underway or completed by international stakeholders that contribute to a strengthening of global air cargo security outcomes. Its purpose is to:

- a) clearly articulate the multi-faceted solution being progressed across a complex system with multiple stakeholders;
- b) identify linkages, synergies and opportunities for international collaboration;
- c) promote an understanding of the roles and responsibilities that all stakeholders play; and
- d) encourage momentum in the process by identifying status of activities and encouraging forward planning.

This Roadmap should be reviewed periodically to reflect new and progressing activities.

This Roadmap is applicable to air cargo and mail security. For the purpose of brevity the generally refers to air cargo with some specific references to mail. References to air cargo should be taken to include mail.

Overarching Goal A global air cargo system that is more secure against the threat of unlawful interference.
