On 7 August 2014, the Lomé Declaration on the Development of Air Cargo in Africa was adopted.

On 27 March 2015, the **Antananarivo Declaration on the Sustainable Development of Air Transport in Africa** was adopted.

These strategic documents (attached) set a roadmap for the sustainable development of air transport on the Continent, both passenger and cargo transport. As you also certainly remember, **Ethiopia** has kindly offered to host the **Second ICAO Meeting on the Development of Air Cargo in Africa** in **Addis Ababa**, during the summer of **2016**.

In preparation for such follow-up meetings, the ICAO Secretariat has developed an interactive electronic platform to assist States in implementing the two Declarations. This platform is called **State Air Transport Action Plan System (SATAPS)**.

Registration to this platform can be completed at: https://portal.icao.int/.

Please designate one main focal point and one alternate focal point, who will have sole access to the secure portal. Instructions to access the website - and to register on the ICAO secure portal if necessary - are attached to this message.

We would like to ask you to kindly review the documents attached, and provide, for each area, the status of completion of the Declarations by your State. Please upload relevant documents as well.

This information will allow:

(i) More efficient preparation of the 2016 meeting, in cooperation with the Chairman of the 2014 Meeting - by focusing efforts on areas that are most in need of assistance for implementation;

(ii) In the long-run, to benefit from a mechanism to monitor and facilitate the implementation of action plans in the air transport economic regulation field.

Thank you very much for your cooperation. We are looking forward to receiving your feedback on the website, by 15 December at the latest.

I want to cordially inform you that Togo has designated two focal points here after:

- 1. MR. PELENGUEI Magnouréwa, Director of air transportation, main focal point and
- 2. Mrs. MEDEZI Magnim, legal person at the directorate of air transportation, alternate focal point.
