Subject: Conference on the Economics of Airports and Air Navigation Services (ANSConf 2000) and preparatory Seminar (Montreal, 19-28 June 2000)

Action required: 1) Reply concerning attendance, if not already done so; 2) Note programme for preparatory Seminar at Attachment A;

- 3) Submit working papers as soon as possible; and
- 4) Make early arrangements for hotel accommodation

Sir/Madam,

I have the honour to refer to the *Conference on the Economics of Airports and Air Navigation Services* (ANSConf 2000) which, together with a preparatory seminar, will take place from 19 to 28 June 2000 in the Assembly Hall at ICAO Headquarters.

An invitation to attend these important events, along with the Agenda for the Conference, was sent to you through State letter SR 167/1-99/80 dated 6 August 1999. I now provide, at Attachment A, the current Programme for the preparatory Seminar, which will take place on Monday, 19 June and on the morning of Tuesday, 20 June. As you will see, the Seminar will take the form of presentations and a panel discussion by experts on key topics which will subsequently be addressed by the Conference; there will be provision for questions and answers from the floor.

If you have not yet responded to the invitation to the Seminar and the Conference, I should be grateful if you would do so as soon as possible and indicate the names of your representatives.

Organizational and procedural arrangements for the Conference are comprehensively covered in ANSConf-WP/2, which has already been distributed. Some key or additional information follows below.

Registration. Registration for the Conference and the Seminar will be done concurrently. Registration will take place on Friday, 16 June and Sunday, 18 June from 1300 to 1700 hours and on Monday, 19 June and Tuesday, 20 June from 0800 to 1700 hours. For those unable to register at those times, a registration desk will be open daily from 21 to 23 June from 0900 to 1700 hours. Separate arrangements will be made for those delegates arriving after 23 June.

Credentials. Credentials are required. Such credentials should be signed on behalf of the State or organization concerned, by a person duly authorized thereto, giving the name and position of each member of the delegation and indicating the capacity in which he or she is to serve at the Conference. The credentials may be sent in advance to the Secretary General or be deposited when registering with the Secretary of the Conference (the Director of the Air Transport Bureau) or through his designated Credentials Coordinator.

Opening sessions. The Seminar will commence promptly on Monday, 19 June at 0930 hours with no opening formalities. The Conference will begin with opening formalities on Tuesday, 20 June at 1400 hours. In view of the limited time available, there is no provision for opening statements and, following the formalities, the Conference will proceed immediately to the first Agenda Item.

Working papers. Working papers prepared by States or Observers should be as brief as possible. As a consequence of a heavy meetings programme and continuing resource constraints, the Organization can no longer translate working papers longer than six pages (including attachments), working papers presented by Observers (including international organizations), or any information papers. Such papers will therefore be produced in the original language only (unless a translation already exists or is provided by the State or organization concerned). Submission is encouraged on computer diskette or other electronic means, with identification of the word processing system used. Working papers which have not already been received at ICAO Headquarters will normally be distributed only at the Conference.

Exhibition. A contact booth exhibition associated with the Conference, with 15 exhibitors, will be held in the vicinity of the Assembly Hall from Wednesday, 21 June through Friday, 23 June.

Visa requirements. In compliance with paragraph 3.7 of Annex 9 to the Convention on International Civil Aviation, Canada has already dispensed with the requirement of entrance visas for temporary visitors of a considerable number of States. However, those participants for whom visas continue to be required for entry into Canada are invited to take steps to obtain these visas in good time from the nearest Canadian authorities.

Hotels. A list of representative hotels and apartment hotels within reasonable distance from ICAO Headquarters and a map of Montreal is at Attachment B. Reservations may be made directly to the hotel of your choice or through the ICAO American Express Travel Services, telephone number (514) 954-8102, facsimile number (514) 954-6758. The rates quoted are subject to confirmation on placement of reservations. Delegates should specify that they are attending an ICAO meeting. Please note that hotel accommodation is very limited in the vicinity of the ICAO offices on the nights of 16 to 18 June because of a major international event taking place in Montreal; if necessary, participants may wish to consider taking accommodation further afield at that time.

Web sites. Updated information concerning the Conference, including working papers as they become available, may be found on the ICAO web site (www.icao.int). Further information about Montreal, including

additional hotel accommodation prices and locations, may be found on the Montreal Official Tourist Information Web Site at http://www.tourism-montreal.org.

The theme of the Conference is Air transport infrastructure for the 21st century. The Conference will be addressing from both a practical as well as a policy perspective the major economic challenges facing the provision of airports and air navigation services, including the role of the State. I look forward to seeing you or your representatives in Montreal on 19 June.
