# ORGANISATIONAL AND FINANCIAL ASPECTS OF SWISS AIRPORTS AND SWISSCONTROL

(Presented by Switzerland)

#### INFORMATION PAPER

#### **SUMMARY**

This Information Paper provides a brief description of the organisation of national airports and of Swisscontrol, as well as their modes of financing.

#### 1. **Introduction**

- 1.1 Switzerland, as a small multi-cultural country in Western Europe can avail of three intercontinental airports and an independent company providing air navigation services.
- 1.2 The three platforms of the respective airports are based on three different legal statutes:
  - S Bi-national airport co-owned by France and Switzerland for the Airport of Basle-Mulhouse (since 4 July1949)
  - S Public autonomous airport for Geneva International Airport (since 1 January 1994)
  - S Mixed-economy incorporated company for Zurich Airport (since 1 April 2000)

Swisscontrol, a Swiss corporation for providing air navigation services, has been given the responsibility for the management of civil air traffic in Switzerland. Majority shareholder is the Swiss Confederation; the company is financially independent since January 1, 1996.

1.3 The development of air traffic in Switzerland has necessitated an adaption of Swiss civil aviation policy. In this context, the national airports, the regional aerodromes, the airfields, heliports and grass strips have been merged into a global system. The aeronautical infrastructure therefore takes the form of a network in which every installation is allocated specific functions and performing closely defined services. The national airports of Basel-Mulhouse, Geneva and Zurich consequently are encouraged to closely cooperate with each other and make the best use of their specific market opportunities in sharing traffic in a rational manner as part of the « Swiss airport system ».

# 2.2. Financial aspects

# For Geneva International Airport:

# **Charges setting:**

The regulation of charges is not subject to approval of the regulatory authority; however, a consultation process between the different partners and official bodies is established

# **Sources of financing:**

Internal financing from aeronautical and non-aeronautical charges External financing from bank loans

### For Zurich Airport:

#### **Charges setting:**

The Canton of Zurich will approve airport charges until 2001. As a part of the renewal of the federal concession during 2001, the competence in charges matters will then be delegated to the new privatised entity of « Zurich Airport ».

Consultation procedures with airport users. Supervision of airport charges by FOCA.

# **Sources of financing:**

- · predominantly internally by aeronautical and non-aeronautical charges
- · bank loans

## For Basel-Mulhouse Airport:

#### **Charges setting:**

- · consultation and approval procedures by the official Swiss and French authorities
- · consultation procedures of the different partners
- · approval by the Administration Council of the Airport

#### **Sources of financing:**

- · internally by aeronautical and non-aeronautical charges
- externally by:
  - bank loans,
  - loans by partners
  - subsidies by local communities, French and Swiss states

## 3. Air navigation services

## 3.1 **Organisational aspects**

#### Main activities

- The airspace is divided into two regions, both of them have their own enroute control center. The centers are located in Geneva and Zurich.
- Approach control is provided at the four most important airport levels: Zurich, Geneva, Berne and Lugano, with the exception of Basel-Mulhouse airport, where air traffic control is provided by France. In the case of the three regional airports, Grenchen, St. Gallen-

Altenrhein and Les Eplatures, air traffic control has been delegated to the respective airport authorities by Swisscontrol.

The division of airspace between civil and military is completely coordinated. A national civil-military unit is responsible for airspace coordination. This coordination is also established at directoral and technical levels.

#### Regulator

In the area of flight safety Swisscontrol is regulated by the Federal Office for Civil Aviation, representing the Swiss state. At the economic regulatory level Swisscontrol is considered to be a non-profit corporation providing air traffic control management. As a consequence, over- and under-recovery of the costs of providing air traffic control are redistributed / recharged to the users in future cost bases.

#### Other services

In line with the activities of the company, Swisscontrol also offers other services:

- · Air traffic controller training; the academy, situated in Zurich, owns different simulators.
- PANS-OPS calculations: development of instrument approach and departure procedures, positioning of navigation systems, production of standard aeronautical charts.
- Simulations in accelerated time mode: optimisation of airspace structure and airspace sectorisation, air traffic flow management for airports.
- Calibration flights: Swisscontrol, in partnership with DFS of Germany and Austro Control
  of Austria, as an entity Flight Inspection International, specialises in the field of flight inspection of air navigation systems.

#### 3.2 Financial aspects

#### **Charges setting**

The charges for air navigation services set by Swisscontrol, after being presented in a consultation process with the users, must be approved by the Swiss Confederation.

#### Sources of financing

- · Self-financing with charges for air navigation services
- · External financing with bank loans and loans from the Swiss Confederation
