Margaret ARBLASTER, General Manager, Australian Competition and Consumer Commission (ACCC)

In May 2008, Margaret Arblaster was appointed General Manager of a newly created Fuel Price Monitoring Branch at the Australian Competition and Consumer Commission (ACCC). Prior to this, Margaret was General Manager of the Transport and Prices Oversight Branch in the Regulatory Affairs Division of the ACCC. In this position,

Margaret was responsible for the management of the ACCC's economic regulation work in the transport sector and in some other industries including postal services.

In this, and in former roles at the Prices Surveillance Authority, Margaret has had 17 years experience overseeing the implementation of a wide variety of economic regulatory arrangements for major airports and for air navigation services in Australia, including prices surveillance, price caps, third party access regimes, price monitoring and leadership of a public inquiry into Australian airport charges prior to the privatization of Australian airports, amongst other management responsibilities. Margaret was Chairperson of the Transport Economic Forum in 2006 and President of the Economics Society of Australia, Victorian Branch in 2007.

John **BEGIN**, Deputy Director, Air Transport Bureau International Civil Aviation Aviation Organization (ICAO)

John holds degrees in Business Management with a focus in economics and human resources development and a Law Degree with a focus in environmental regulation. He has held a variety of management positions over the past 30 years in the aerospace and airline industries, most recently as the Managing Director for Safety and Environment at the corporate level of Northwest Airlines. John has extensive experience with

all facets of the environmental field including active involvement in the issues of climate change, local air quality and aircraft noise. He has managed industrial safety programs, has expertise in munitions and explosives safety, is an experienced facility security officer dealing with military classified programs, and has several years of experience as an analytical chemist in an environmental laboratory. Rodrigo VILA DE BENAVENT, Head of the Infrastructure and Airports Unit, European Commission, Directorate General Energy and Transport

Rodrigo Vila de Benavent was born in Madrid - Spain. He obtained his law degree in 1983 and an additional degree in biology in 2004.

Following the accession of Spain to the then European Communities, he joined the Directorate-General for Transport of the European Commission in 1987 as a lawyer. During the year of 1990 he was detached to the ministry of transport in Spain as adviser responsible for maritime issues.

From 1994 to 1998 he was responsible for legal affairs, transport policy and relations with developing countries in the personal cabinet of Commissioner Oreja. Between 1998 and 2002, he mainly coordinated issues relating to the countries of the Pacific and Southern Africa in the Directorate-General for Development and was appointed Head of the Commission's Office for Overseas Territories in the Pacific.

He was nominated head of unit upon returning to the Directorate-General for Energy and Transport in 2002 where he, since then, has subsequently been responsible for the units of "Aviation Safety and Environment", "Inland waterways short sea shipping and ports" and, since 2006, "Airports and infrastructure".



Martyn **BOOTH**, Executive Director, Global Head of Airports, Macquarie Capital Funds

Martyn Booth is an Executive Director, Global Head of Airports, of Macquarie Capital Funds. He joined Macquarie in October 2000 when The Portland Group, the international consulting business which Martyn co-founded in 1994, was acquired by Macquarie. The Portland Group was one of the world's leading international consultancies on airport privatization and management. It worked for governments, airport owners and managers and for bidding consortia in over 30 countries and was an

advisor to the World Bank on economic regulation.

Harry, BUSH, CB, Group Director, Economic Regulation, Civil Aviation Authority, United Kingdom

Harry Bush joined the CAA in March 2003 as Group Director Economic Regulation, responsible for economic regulation of the four designated airports, Heathrow, Gatwick, Stansted and Manchester, and of National Air Traffic Services, and developing economic policy in the CAA's role as Aviation Policy Adviser to Government. He is a member of Eurocontrol's Performance Review Commission and of the UK Government's Commission for Integrated Transport. He is a Fellow of the Royal Aeronautical Society.

Prior to joining the CAA Harry had a 23-year career at the UK Treasury. Angela has held top executive positions at three of the largest US airport systems. Under her direction, Miami International Airport attained international recognition for its environmental achievements with ISO 14001 certification, the first airport in the US to do so. In addition to a multi-billion capital improvement programme, the business plan that she instigated restored MIA's competitiveness in cargo and passenger markets after years of decline, garnering the participation and support of the airlines, airport management staff and the governing authority.

Assad KOTAITE, President Emeritus of the Council of the International Civil Aviation Organization (ICAO)

Assad Kotaite was born in Hasbaya, Lebanon, on 6 November 1924. He graduated in Law from the French University of Beirut (1948) and received a Doctor of Law from the University of Paris (1952). He also studied at the Institut des hautes études internationales, University of Paris and the Academy of International Law, The Hague. In 1952, he was elected President of the Association of Attenders and Alumni of The Hague Academy of International Law.

From 1953 to 1956, Dr. Kotaite was Chief of Legal Services, International Agreements and External Relations, in the Lebanese Directorate of Civil Aviation. From 1953 to 1970, he was a member of the Legal Committee of ICAO and he was the Representative of Lebanon on the Council of ICAO from 1956 to 1962 and again from 1965 until July 1970. From 1957 to 1959, he was a member of the United Nations Transport and Communications Commission and served as Chairman of the Ninth Session of that Commission. During Dr Kotaite's term as a member of the ICAO Council, he served as Chairman of the Air Transport Committee from 1959 to 1962 and again from 1965 to 1968, as Second Vice-President of the ICAO Council in 1958 and as member and Vice-Chairman of the ICAO Finance Committee and Chairman of the Working Group on ICAO Financial Regulations in 1959. For several years he was a member of the ICAO Standing Group on Implementation. During the period from 1963 to 1964, when he did not serve on the ICAO Council, he was Chief of Administrative Services, Directorate General of Transport of Lebanon.

Dr. Kotaite was Secretary General of ICAO from 1 August 1970 until 1 August 1976 when he became President of the Council of ICAO. He retired on 31 July 2006, having served for 53 years the international civil aviation community, the last 30 of which were as President of the Council.

Robin PADGETT, Vice President, Procurement Operations, Emirates Airlines

Based in Dubai, United Arab Emirates, Robin is Emirates' Vice President Procurement prior to this he was with bmi (formally British Midland Airways) in the United kingdom. Originally Robin trained as an economist and has 15 years of experience in aviation; in addition, he has worked in industries as diverse as insurance and retail. Along with his team of procurement professionals he is responsible for the acquisition of all goods and services that the Emirates requires for its

normal day to day operations, ranging from jet fuel, in-flight catering, ground handling, airports and air traffic charges through to hotels for crew rest. Robin has actively been involved in Airport and Air Traffic control charges since the early 1990's negotiating with suppliers across the globe. He has been a vocal advocate for cost efficiency in this strategically important part of the aviation industry.

For the last three years he has chaired IATA's Airport and Air Traffic Control Charges Working Group which is the focal point for the world's scheduled airlines' efforts to control these costs.

Jeff POOLE, Director, Industry Charges, Fuel and Taxation, International Air Transport Association (IATA)

Jeff Poole is responsible for achieving significant cost reductions in the airport costs and air navigation charges of \$45 billion a year to IATA Member airlines for their international operations (about 10% of the global operational costs of all airlines). He is also responsible for IATA's commercial fuel activities, including fuel charges and reliability of fuel supply, and for industry taxation matters affecting IATA Member airlines.

Jeff joined IATA in February 2004 following a career at Airbus, Toulouse and in the defence industry with BAESYSTEMS. His last position at Airbus was as Senior Vice President for Procurement Strategy and Services, covering a \$20 billion per annum spend. Prior to that, Jeff was responsible for development of all business aspects of the Airbus A3XX (now A380) programme. Alexander TER KUILE, Secretary General, Civil Air Navigation Services Organisation, CANSO

Alexander ter Kuile was appointed Secretary General of CANSO in January 2001. CANSO represents the interests of the world's Air Navigation Services Providers (ANSPs). CANSO Members control over 80 per cent of global air traffic and serve over 70 per cent of world airspace. In recent years CANSO has grown to become the global voice for Air Traffic Management. Today the organization represents 47 ANSPs and 40 associates, all stakeholders in the aviation community.

CANSO represents the world's ANSPs across a broad range of subjects from institutional, governance & regulatory issues, to safety, airspace operations, customer relations, finance, technology, and human resources. CANSO works closely with both State and industry partners towards achieving a safe, harmonious and interoperable global airspace that offers sufficient capacity in a cost-effective manner.

Before joining CANSO, Alexander was a Director at Simat Helliessen & Eichner (SH&E), the New York based air transport consultant, where he supported airline privatizations and airline alliance partner selections in Africa, Asia and Europe. He also assisted Civil Aviation Authorities and airport operators in addressing strategic air transport issues.
