2.2 Conference proceedings on 15 September 2008

Conference – opening session

- 2.2.1 The Conference was officially opened by the President of the Council and was addressed by the Chairman of the Air Transport Committee.
- 2.2.2 The Conference adopted its agenda (WP/1) and noted the organizational and working arrangements of the Conference in WP/2.
- 2.2.3 The Conference elected Mr. Dan Cogliati, Senior Strategic Policy Advisor Air Policy, Transport Canada as the Chairman, Ms. Siew Huay Tan, Director (Legal), Civil Aviation Authority of Singapore as the First Vice-Chairman and Mr. Ramesh Lutchmedial, Director General of Civil Aviation of Trinidad and Tobago as the Second Vice-Chairman.

2.2.4 Following an introduction by the Chairman of Agenda 1 – Issues involving interaction between States, providers and users, the Conference considered sub-item 1.1 – Economic oversight on the basis of the following working and information papers, listed in order of presentation: WPs/4 (presented by the Secretariat), 69, 57, 22, 65, 53, 27, 46, 24 and 71 and information papers WPs/18, 41, 63 and 66. The Conference almost concluded its consideration of sub-item 1.2 – Economic performance and minimum reporting requirements on the basis of WPs/5 (Secretariat), 55, 52, 22, 28, 34, 24 as well as information papers WPs/18, 41, 63 and 56.

2.3 **Draft report**

Draft report material on the proceedings will be developed and submitted by the Secretariat progressively during the Conference. The Conference will review and approve the draft report on the morning of Saturday, 20 September, as indicated in the tentative schedule (WP/3).

2.4 Attendance and list of participants

- 2.4.1 The Conference welcomed more than 600 participants from over 100 Contracting States and numerous organizations with observer status to ICAO as well as participants from industries and academia on its first day.
- 2.4.2 A List of Participants can be expected to be distributed during the day on Wednesday, 17 September 2008, in front of the Document Distribution Centre on the 4th floor of the Conference Centre.
