

## CEANS Pre-Conference Symposium 14 September 2008

## Opening address by the Director, Air Transport Bureau Mrs Folasade Odutola

I would like to join the Secretary General, Dr. Chérif in welcoming you all to ICAO Headquarters for this important event. It is also my pleasure to welcome our Moderator for the Symposium, Mr Vijay Poonosamy, and all the speakers and panellists who have graciously accepted our invitation to this timely gathering relating to ICAO's air transport activities.

This Symposium will address the key topics that will be discussed at the CEANS, under the guidance of influential individuals from various sectors of the industry and government authorities. I would like to reaffirm from the very start that the main purpose of this event is to prepare us all for the Conference that starts tomorrow. We are delighted to begin the day setting the scene for the Conference with two high-level presentations. On your behalf, I thank them all sincerely for having accepted our invitation to join us for the Symposium.

Before I invite Mr Poonosamy to take control of this meeting, I would like to mention that the Secretary for this Symposium is Ms. Magda Boulos (on my right/left). Ms Boulos began developing the programme for this event early in the year and I take this opportunity to thank her very much for her excellent work. And now, a few words about our Moderator for today. Mr Vijay Poonoosamy is Vice President of International Affairs of Etihad Airways and a national of Mauritius.
