What is ISO 14298

- Standard for Management of Security Printing Processes
- Management system based on risk management
- Covers security printers and hologram manufacturers
- Managed by Intergraf



Who is Intergraf?

- INTERGRAF's task is to:
- provide a platform for interaction of security printers, suppliers and customers
- promote and protect the interests of security printers, suppliers and their clients via certifications

A brief history

- Main Objectives:
 - One generic (worldwide) standard for security printers
 - Focus on security processes and not only on the (printed) security products
- 2001 From the Industry for the Industry: Intergraf, IHMA, UPU, VPGI with the support of CEN and the European Commission and experts from European security printers
- 2003 CWA (CEN Workshop Agreement) 14641 security management system for secure printing
- 2005 -CWA 15374 completed the security chain : Certification for Suppliers (prepress software, machines, paper suppliers, etc.)
- 2013 ISO 14298



Why is it important?

- ICAO Document 9303 says.... 'The State issuing the MRTD shall ensure that the premises in which the MRTD is printed, bound, personalised and issued are appropriately secure'
- How do you do that and what does it mean?
- Use ISO 14298

How does it work?

- The ISO Standard provides the framework
- Intergraf has set up a list of detailed requirements based on the standard -Intergraf Certification Requirements (ICR)
- These requirements are audited and ensure high-level security of all printing and order related processes



How does it work?

Based upon management of 12 defined risks, covering security of....

- material, product and waste,
- supply chain,
- premises
- processes
- staff
- machinery (including disposal)
- transportation



Who does it apply to?

- There are 3 levels of certification
- All based on market sectors
- Non-Government, Government and Central bank
- Not only security printers, but security component suppliers are covered too





What are the 3 levels?

- NG (Non-Governmental / Security Printing):
- A minimum set of requirements need to be fulfilled by all companies in order to be awarded a certificate with the level NG
- G (Governmental):
- An additional set of requirements need to be fulfilled by all printers certified with the level G
- CB (Central Bank):
- Further requirements for printers supplying central banks or credit card issuing authorities and ID or passport personalisation centres.



How widespread is it?



- Close to 100 certified production plants
- In 45 countries
- Integrated in many tenders every year



- Vey simple!
- Include within your tender requirements that the manufacturer of your blank passport stock must be certified to ISO 14298
- It is free for States!
