Remarks by the President of the Islamic Republic of Iran Civil Aviation Organization Mr. Ali Abedzadeh

I welcome you all to ICAO TRIP Seminar on Machine Readable Travel Documents (MRTDs) and Traveller Identification Management being held here at Kish Island Free Zone for the next three days.

To do so, Civil Aviation Organization does its best to enjoy the knowledge, experience and expertise of the ICAO, member States, stakeholders and industries.

To realize one of the key strategic objectives of the ICAO, namely security as well as our own set strategies, which is actually interwoven with facilitation and connectivity, which, the latter one, recently brought into focus, CAO has strongly supported the holding of this Seminar and

will do so for other issues of paramount importance in the future. The Islamic Republic of Iran would like to play decisive roles in order to be the strongest link of the security chain.

In closing, I would like to take this opportunity to thank you for providing enormous assistance and support in organizing this important Regional event and I do wish you fruitful deliberations.

Nevertheless, I should say that your presence here would bring us an invaluable asset, which would lead to a huge change in the above-mentioned areas.
