 - both aspects must complement and not contradict the other.
- •IOM looks at border management as an integral part of comprehensive migration management. Borders constitute a physical and legal space where many challenges related to migration management surface and culminate.

VERIFIER Travel Document and Bearer (TD&B) System

- •Standalone system used for secondary inspection by immigration and border control officers to assist in **detecting fraudulent and/or altered travel documents** and **identifying imposters**
- •Installed in 14 countries (Asia and the Pacific)







Passport Examination Procedure Manual (PEPM)

- •Second edition due in July 2016
- •The manual addresses the **methodology of travel document/passport examination** on in a logical order, providing practical information on every step of the examination process.
- The manual has been designed for use by border control officials and related agencies involved in migration on management.

 - IOM is already involved in a Public Private Partnerships (PPP) working group on wide variety of migration related topics
