#### H.E. Lieutenant-General Shaikh Rashed bin Abdulla Al Khalifa, Minister of Interior

Shaikh Rashed was appointed Minister of Interior, Kingdom of Bahrain, on 21 May 2004.

Within a very short span of time, he re-organized the Ministry and its various structures, and went on to play a vital role in establishing and enhancing bilateral relations with other countries. Under his leadership, the Ministry has formalized its co-operation with the Interior Ministries of the United States, United Kingdom, Turkey, France, Russia and others.

Keeping in view the trend of greater interaction between the public and the Police, Shaikh Rashed established the innovative Community Police Service in Bahrain, which has tremendously increased the intimacy between the public and the Police. The Ministry has recently also introduced an Independent Ombudsman in line with international standards to investigate and redress complaints from the public.

Shaikh Rashed strongly believes that security is no longer an internal issue. And from that perspective, he took the initiative to organize an international security forum in Bahrain in 2007 and 2009; the first platform of its kind where internationally acclaimed experts, technocrats, and policy makers both from the governmental and private sector attended to exchange views.

#### H.E. Engineer Kamal bin Ahmed Mohammed

His Excellency Kamal bin Ahmed Mohammed was appointed Minister of Transportation in February 2012. He holds overall responsibility for Bahrain's transport infrastructure covering policy, regulation and the development and delivery of projects to meet the Kingdom's future transport needs, as well as the country's postal services.

Additionally, in March 2012, Kamal bin Ahmed was appointed Acting Chief Executive to the Economic Development Board, the public agency with overall responsibility for attracting inward investment into Bahrain and supporting initiatives that help enhance the investment climate in the country.

Prior to his appointment as Transport Minister, Kamal bin Ahmed was Minister of Cabinet Affairs from February 2011. He previously spent 7 years at the Economic Development Board leaving his role as Chief Operating Officer to become a Government Minister. He is currently a board member of the following organisations: Bahrain Mumtalakat Holding Company (Mumtalakat); Bahrain Economic Development Board; Gulf Air; Quality Assurance Authority for Education and Training (QAAET); and Higher Education Council (HEC).

Kamal bin Ahmed holds a Bachelors in Civil Engineering from the University of Bahrain and a Master's Degree in International Project Management from Leeds University.

#### Mr. Raymond Benjamin

Mr. Benjamin has been Secretary General of the International Civil Aviation Organization since August 2009. His extensive career in civil aviation spans more than 30 years. It includes 13 years as Executive Secretary of the European Civil Aviation Conference (ECAC) where he was responsible for the development of policy advice and strategic options to the President and to the 42 Member States of the Conference. Prior to joining ECAC, Mr. Benjamin was Chief of the Aviation Security Branch of the Air Transport Bureau of ICAO from 1989 to 1994. Among his responsibilities was the provision of advice to the Secretary General and the President of the Council on security policy matters and the development of a worldwide airport assessment and technical assistance programme. He also served as Air Transport Officer and Deputy Secretary of ECAC from 1982 to 1989 and held various positions in the Civil Aviation Administration of France from 1973 to 1987

Mr. Benjamin holds a Master's Degree in Public Law and Diplomas from the Institute of Political Studies and the Institute of Higher International Studies, Paris.

A French citizen, he was born on 24 November 1945, in Alexandria, Egypt.



#### Mr. Kunio Mikuriya

Mr. Mikuriya has been Secretary General of the World Customs Organization (WCO) since 1 January 2009. He provides leadership and executive management for the global Customs community's priorities, including developing global Customs instruments, standards, and tools; securing and facilitating global trade; realizing revenues; building Customs-business partnerships; and delivering capacity building in support of Customs reform and modernization. In addition, Mr. Mikuriya is leading efforts in support of

implementation of the World Trade Organization's (WTO) Agreement on Trade Facilitation.

Prior to joining the WCO, he worked for Japan's Ministry of Finance for 25 years. During his career with the Ministry, Mr. Mikuriya occupied a variety of senior posts, which have given him broad experience and knowledge in Customs, trade, development, budget, and financial policies. He served as Director of Enforcement where he led efforts to fight illicit trade, then as Director of Research and International Affairs paving the way for the conclusion of the first regional trade agreement for Japan, and then as a Counsellor in the Tariff and Customs Bureau. He also served as Director of Salaries and Allowances to coordinate remuneration levels for the entire government workforce, and as the Budget Controller for Foreign Affairs, Official Aid, International Trade and Industry, in the Budget Bureau. In addition, he spent time as a Counsellor at the Japanese Mission to the WTO in Geneva and participated in the GATT Uruguay Round trade negotiations.

Mr. Mikuriya has a degree in law from the University of Tokyo and a Ph.D in international relations from the University of Kent.



#### Mr. Bishar Abdirahman Hussein

Mr. Hussein's four-year mandate as Director General of the International Bureau of the Universal Postal Union (UPU) began in January 2013. The UPU is the United Nations' specialized agency for postal services. His vast experience of the postal sector encompasses 30 years and includes time served as CEO of the Kenyan Post. Mr. Hussein is also well versed in UPU and diplomatic matters, having spent six years as Kenyan ambassador to the Gulf region, based in the United Arab Emirates.

Prior to his election as Director General, he chaired the UPU Council of Administration from 2009 to 2012.

#### H.E. Shaikh Mohammed Bin Khalifa Al-Khalifa

Shaikh Mohammed is the President of Customs, Ministry of Interior, Kingdom of Bahrain.

Prior to his current position, he held posts as the Undersecretary of the Ministry of Transportation, as well as successive posts within Financial and Administrative Affairs at the Ministry of Justice and Islamic Affairs. Shaikh Mohammed represents the Kingdom of Bahrain in various regional and international fora. He has contributed to the privatization of the transport and telecommunications sectors and is a holder of the H.H. Sheikh Isa bin Salman Al Khalifa's Award.

He holds a Bachelor`s Degree in Business Administration and has completed a Course in Public Administration for Executives.



#### Mr. Ahmed N. Al Nemah

Mr. At Nemah has been the Acting Undersecretary for Civil Aviation Affairs for the Kingdom of Bahrain since January 2013. He reports directly to The Minister of Transportation and is responsible for all issues related to civil aviation for the Kingdom of Bahrain.

In his capacity as Acting Undersecretary, he is responsible for overseeing the strategic development of Aviation Services in Bahrain. He is also instrumental in developing and implementing an open skies policy for the Kingdom, including securing the interest of the national carrier Gulf Air in the international market through bilateral negotiations.

In addition, his responsibilities include successful negotiations of aviation bilateral agreements and achieving open skies agreements with nations worldwide. Mr. Al Nemah also serves on the Supreme Organising Committee for the Bahrain International Airshow as appointed by H.H. The Prime Minister of the Kingdom of Bahrain.

Mr. Al Nemah began his career with Bahrain Civil Aviation in 1978 as an air traffic controller. Prior to his appointment as the Acting Undersecretary for Civil Aviation Affairs, he was the Assistant Undersecretary for Civil Aviation Affairs from 2005-2013 and the Director of Air Transport from 2001-2005.



#### Mr. Douglas Brittin

Mr. Brittin was appointed to the position of Secretary General at The International Air Cargo Association (TIACA) in August 2013.

Prior to TIACA he served in the United States Department of Homeland Security's Transportation Security Administration (TSA) Air Cargo Office. Upon joining TSA in June 2007 as Air Cargo Manager, he was responsible for the development of the Certified Cargo Screening Program in the United States, as well as forwarder security programmes and screening technology development.

He was promoted to the TSA's Senior Executive Service (T-SES) as Division Director, Air Cargo at TSA headquarters in Arlington, Virginia in May 2010, where he was additionally responsible for global air cargo security policy, vulnerability assessments, all-cargo operator programmes and industry engagement, managing a budget of \$122 million and a staff of security experts, programme managers and contractors.

Mr. Brittin has held executive level sales, marketing and operations positions within the transportation and logistics industry at companies such as BAX Global, Panalpina, Emery, and Menlo Worldwide. He has over 30 years' experience in the industry, including the rail and trucking sectors.

Mr. Brittin is a graduate of the University of Denver.



#### Mr Fd Broekema

Mr. Broekema is Senior Policy Advisor, Ministry of Finance, Customs and Consumer Tax Directorate, the Netherlands. He worked for more than 41 years in the Customs environment, including for the past 20 years in national and international Customs policy and legislation, with specific experience in trade facilitation, harmonization and standardization of Customs procedures; IT, data requirements etc.

Mr. Broekema was a delegate for the Netherlands for many years in international meetings at the WCO, IMO, ICAO, ECAC and the EU and chaired for these organizations a number of committees, project groups, and working groups.

From 1995 to 2011, he served as a delegate involved in the negotiations on the Revision of the WCO Revised Kyoto Convention.

Finally, since 2010, Mr. Broekema has been involved in work related to aviation security for the WCO, ECAC and the EU, including cargo-related matters and passenger-related information.



#### Mr. Daniel Cortez

Mr. Cortez is in a secondment position as the Postal Security Program Manager at the UPU. He implements the Postal Security Group's work plans and is the UPU's chief security officer. He serves as the primary liaison with international organizations for collaboration on safety and security matters affecting the world's posts.

Mr. Cortez is a United States Postal Inspector with the United States Postal Service (USPS) Postal Inspection Service, which he joined in 1991 after working with the United States Department of Justice. The Postal Inspection Service serves as the federal law enforcement agency for the USPS. His career has focused on protecting the USPS by implementing and executing programmes relating to security, emergency preparedness, risk assessments and criminal investigations.

#### Mr. Mark Dillon

Mr. Dillon is Senior Policy Advisor, Her Majesty's Revenue and Customs (HMRC).

He has policy responsibilities for Supply Chain Security and Mutual Recognition. He represents HMRC in a wide range of European Union and World Customs Organisation meetings, and has been actively involved in the two European Union Air Cargo Security Pilots (Courier and PRECISE) from their beginning.

Mr. Dillon joined Her Majesty's Customs and Excise in 1979 as an officer in London Port and went on to work in other ports in both landing and shipping and anti-smuggling roles. Returning to London in 1989, he was part of the IT development team for the United Kingdom's main customs declaration processing system called CHIEF, which he went on to manage operationally.

Prior to his current role, he was a United Kingdom Project Manager responsible for delivering all of the United Kingdom business and IT aspects of the European Union Export Control System.

#### Mr. Carlos Grau Tanner

Mr. Grau Tanner, a Spanish and Swiss citizen, is the Director General of the Global Express Association, which represents DHL Express, FedEx Express, TNT Express and UPS. In this capacity, he is involved in international policy issues in the areas of trade, trade facilitation, customs, post, and civil aviation, including air cargo security.

#### Mr. Justin Jedlinski

Mr. Jedlinski has over 15 years of experience in supply chain and transportation security.

Since joining Transport Canada in 2009, Mr. Jedlinski has had significant involvement in the design, development and implementation of Canada's National Air Cargo Security Program.

Most recently, he has been responsible for leading Transport Canada's air cargo security commitments under the PACT (Preload Air Cargo Targeting) pilot project jointly administered with the Canada Border Services Agency (CBSA), in addition to efforts on mutual recognition, harmonization, and capacity development.

Ms. Kang is the programme manager for the Air Cargo Advance Screening (ACAS) pilot for United States Customs and Border Protection (CBP), Department of Homeland Security, developing policies based on national operations targeting high-risk cargo, and leading consultations with industry. As the CBP lead responsible for transitioning the ACAS pilot into a regulation, she initiated the rulemaking process in 2013.

#### Ms. Ebby Khaguli

#### Mr. Bernard Lim

Mr. Lim is Director for International Relations and Security with the Ministry of Transport, Singapore. His key responsibilities include formulating and managing policy matters concerning international relations, transport security and transport emergency preparedness in Singapore.

He is currently the Chairman of the International Civil Aviation Organization Aviation Security Panel (since 2011) and also the Vice-Chairman of the Asia-Pacific Economic Co-operation Aviation Security Experts Sub-Group. He had also led the ICAO Aviation Security Panel Working Group that developed the ICAO Comprehensive Aviation Security Strategy (2011-2016); the Working Group on Guidance Material; the Working Group on Screening of Non-Passengers; and is currently the Rapporteur for the Working Group on Air Cargo Security.

Mr. Lim is also a member of various crisis management teams. He was involved in the management of major crisis incidents such as the air crash of SilkAir flight MI185 and Singapore Airlines SQ006; the management of aviation security operations in the immediate aftermath of the terrorist attacks of 9/11, Severe Acute Respiratory Syndrome (SARS), H1N1, and other incidents.

Mr. Lim holds a Master's Degree in Public Administration from the University of Liverpool, United Kingdom. He was trained in crisis management at the Emergency Planning College in York, United Kingdom, and in Leadership at the John F Kennedy School of Government, Harvard University. He has received several awards including the Public Administration Medal (Silver) in 2012.

#### Ms. Hellen Nthenya Makau
