**7. General Information**

**a) Local Transportation**

The recommended method of transportation is taxi.

**b) Money Exchange**

The Eastern Caribbean Dollar (ECD) is the national currency of Antigua and Barbuda. The exchange rate is approximately 1USD\$ = ECD\$2.70.

**c) Credit Cards**

The international credit cards usually accepted in shopping centres, hotels, and restaurants are American Express (AMEX), Diners, Master Card and Visa.

**d) Commercial Working Hours**

Banking hours are generally from 08:00 – 14:00 hours from Mondays to Thursdays and on Fridays, banking hours are from 08:00 until 16:00 hours. Some local branches of banks are open on Saturdays from 09:00 until 13:00 hours.

**e) Visas**

A valid passport is required to get into Antigua and Barbuda. It is possible that nationals of certain States require visa for entry, it is advisable to verify this requirements with the United Kingdom Consulate or Embassy in your State.

**8. Hospital**

Participants should have medical insurance or medical coverage from their respective governments to meet expenses, if any, towards sickness or a medical emergency during the above named seminar. ICAO, LACAC or the Government of Antigua and Barbuda (Ministry of Civil Aviation) takes no responsibility to meet expenses in this regard.
