Agenda Item 1: Review and approve the February RASG-PA ESC draft teleconference meeting agenda

1.1 The ESC reviewed and approved the agenda as presented.

Agenda Item 2: Review draft RASG-PA ESC January Summary of Discussion

2.1 The ESC reviewed and approved the summary of discussion as amended to reflect the outstanding issue of "Business Case to Mitigate Runway Excursions."

Agenda Item 3: Review of RASG-PA Action Item List

3.1 The ESC reviewed current list of ESC action items. All items were current and up to date.

Agenda Item 4: Review of RASG-PA Conclusions and Decisions

- 4.1 The ESC reviewed the current list of valid and closed RASG-PA Conclusions and Decisions.
- 4.2 The ESC Decision 10/7, was amended to reflect the item as still valid.

Agenda Item 5: Work Group/Projects updates and status

5.1 Pan America - Regional Aviation Safety Team (PA-RAST)

- 5.1.1 PA-RAST agenda is being developed for PA-RAST meeting in Jamaica.
- 5.1.2 Eduardo Chacin will be assuming the Secretariat responsibilities for the PA-RAST. Mr Miguel Marin will be providing ICAO oversight for all RASG's globally.

5.2 Annual Safety Report Team (ASRT)

- 5.2.1 The ESC was briefed that the final version of the second edition of the annual safety report has been delivered to the RASG-PA Secretary.
- 5.2.2 Official State letter is being prepared informing States of the availability of the annual safety report.
- 5.2.3 As part of the safety report distribution, the RASG-PA Secretary will print hard copies of the safety report and mail to all DGCA's in the Pan American region in addition to ICAO council members.
- 5.3.4 Mr Oscar Quesada urged RASG-PA stakeholders that contribute safety report data to prepare the information as soon as possible in order to develop the third edition of the safety report for 2012.

5.3 Aviation Safety Training Team (ASTT)

- 5.3.1 The ESC discussed the initiative to translate the updated ALAR Toolkit into Portuguese and Spanish.
- 5.3.2 Mr. Eduardo Chacin briefed the ESC that the Colegio de Pilotos already has an ALAR Toolkit workshop in Spanish. Eduardo is going to meet with the Colegio de Pilotos to determine if the translation has already been accomplished.
- 5.3.3 A RASG-PA Aviation Safety Workshop was scheduled for Mexico City, Mexico, 30-31 January, in the ICAO Mexico City office.
- 5.3.4 There were approximately 80 attendees from diverse organizations including: Pilots, Controllers, Airlines, Colegio de Pilotos, Colegio de Controladores, ASA, ACI-LAC, CANSO, IFALPA and Mexico DGAC. The next safety workshop is scheduled for Suriname through the coordination of the ICAO Lima office. Suriname has indicated that tentatively agree to support
- 5.3.5 The previously postponed Caribbean Aviation Safety Workshop is still being considered however it is pending a location and sponsor.

5.4 RASG-PA Project: GSI/3.A - Protection of Safety Information

- 5.4.1 Boeing has advised RASG-PA that they are ready to meet with all interested parties to discuss the "Model Law" document.
- 5.4.2 A tentative date of 23-24 February 2012, at the Mexico City ICAO office, has been agreed upon. The RASG-PA Secretary will send letter to participants to coordinate the meeting.
- 5.4.3 Boeing and Airbus will provide all participants a list of concerns prior to the meeting.

5.5 RASG-PA GSI-4 Project (COCESNA/ACSA Accident/Incident Investigation Board) CIPA

- 5.5.1 Mr. Miguel Pacheco, COCESNA/ACSA was not able to attend the teleconference but briefed the ESC through a written update on the following items.
- 5.5.2 A letter of understanding between ACSA and the DGAC Costa Rica (Unidad de Accidentes) has been realized.
- 5.5.3 The change of government in Guatemala has delayed the assistance that was being provided by COCESNA/ACSA.
- 5.5.4 The new DGAC of Guatemala will be briefed on the assistance that was being provided and the joint activities should proceed as normal.
- 5.5.5 El Salvador and Honduras have recently requested assistance from ACSA in the area of accident/incident investigation. A team from ACSA will be traveling to El Salvador and Honduras to set up a plan of action on how the assistance will be accomplished
- 5.5.6 Miguel will be traveling to Belize in March to assist them on Annex 13 materials.

5.6 RASG-PA GSI-12 Project (Flight Data Analysis)

- 5.6.1 Mr. Rolando Ramirez, COCESNA/ACSA, briefed the ESC that the two participating operators had sent a summary of the information on unstabilized approaches that had been provided over the last six months. The project participants will discuss this information during 23 February meeting.
- 5.6.2 Rolando also briefed the ESC that the operators had mentioned some concerns about the El Salvador terminal airspace. COCESNA/ACSA will travel to El Salvador to develop mitigating initiatives if necessary to address these concerns. The DGAC of Costa Rica has also agreed to assist El Salvador if possible.
- 5.6.3 COCESNA/ACSA also briefed that the new visual maneuver to land on runway 25 at Juan Santamaria Costa Rica Airport was published.

5.7 ASIAS

5.7.1 One of the main focuses of the next PA-RAST meeting will be to review ASIAS data and strategize how to best move forward with the information.

5.7.2 First order of business for RASG-PA ESC/12 meeting will be to provide the ESC a presentation on ASIAS and also a recommendation on how best use or develop the information within the RASG-PA framework.

5.8 RASG-PA Project: ICAO ATC Spanish Phraseology

- 5.8.1 ALTA developed and forwarded a survey to 6-9 airlines requesting data on the need to improve the use of standard ICAO Spanish phraseology. Initial results acknowledge that there is a problem with Spanish ATC phraseology.
- 5.8.2 The survey results so far indicate that the highest percentage of non-standard phraseology is in the approach and ground phase of flight.
- 5.8.3 ALTA is working with COCESNA to develop an additional survey to be sent to air traffic control personnel. The hope is to survey at least 300 air traffic controllers and define where the major phraseology problems lie.

Agenda Item 6: RASG-PA Business Case to Mitigate Runway Excursions

- 6.1 The ESC discussed the issue of moving forward with the RASG-PA Business Case to Mitigate Runway Excursions. During the January ESC teleconference there was a discussion reference whether we should continue with this project considering that the CAST JMDAT group was also working on a similar effort.
- 6.2 It was clarified that the scope of the CAST work and the scope of the RASG-PA business case were not similar and therefore the ESC supported moving forward with the business case project.
- 6.3 Mr. Oscar Quesda briefed the ESC that the ICAO Lima office has a course scheduled on how to develop a business case. The objective is to bring awareness to the region, that along with a technical argument for moving forward on safety initiatives, it is also important to have the financial impact as well.

Agenda Item 7: RASG-PA/05 – Update/status

- 7.1 The ESC discussed the status of holding the RASG-PA/05 Meeting jointly with the Flight Safety Foundation in Santiago, Chile.
- 7.2 Chile has advised they support the initiative but they need to seek bids for hotel space regarding the RASG-PA/05 Meeting.
- 7.3 Several ESC members were concerned about holding the PA-RAST and ESC meetings over the weekend, which will be necessary due to scheduling issues for both organizations.
- 7.4 Another concerned that was raised was the cost for RASG-PA members to attend the FSF Meeting. The FSF representative advised the ESC that the FSF is aware of the issue and would respond to RASG-PA in the near future.

Agenda Item 8: Flight Safety Foundation - ESC Membership

- 8.1 RASG-PA Secretariat thanked the Flight Safety Foundation (FSF) for joining the RASG-PA ESC.
- 8.2 FSF briefed the ESC that they are giving more emphasis to the entire Latin American region considering the rate of growth and the have begun some projects in the area.

Agenda Item 9: Other Matters

10.1 RASG-PA Secretariat urged ESC members who will be attending the ESC and PA-RAST Meeting in Jamaica, to make hotel arrangements as soon as possible. Some of the hotels that were previously suggested are no longer available.
