1. Introduction

- 1.1 The ASTT delivers Aviation Safety Workshops/Seminars, collects and posts aviation safety training material on the RASG-PA website: www.rasg-pa.org/ and holds meetings, as required, in order to coordinate and ensure implementation of workgroup objectives.
- 1.2 The ASTT Aviation Safety Workshops/Seminars include sharing specific RASG-PA data-driven safety information to mitigate the top three risk areas in the Pan American Region and also provides ICAO information on improving safety oversight systems, implementing the ICAO State Safety Programme (SSP) and Safety Management Systems (SMS), promoting implementation of Runway Safety Teams (RSTs), utilization of ICAO Electronic Safety Tools, information on fatigue, pilot monitoring, Performance Based Navigation (PBN), etc.

2. RASG-PA/ASTT activities update

- 2.1 As a result of the letter sent by the RASG-PA Secretariat inviting States/Territories, International Organizations and Industry to sponsor ASTT activities, the Secretariat received two invitations: Antigua and Barbuda and Volaris, which is an international airline based in Mexico.
- 2.2 Considering that the workshops/seminars assist States with raising awareness, preparing and informing personnel and the local aviation community on up-to-date safety related issues, the Ministry of Tourism, Civil Aviation and Culture of Antigua and Barbuda requested a three-day workshop/seminar.
