As you may already know, the NACC/WG Meeting is the plenary meeting that is held every three years during the year following the ICAO Assembly. It brings together the air navigation experts from the NAM/CAR Regions representing all air navigation fields (AGA, AIM, ATM, CNS, MET and SAR), including the MET and AGA Projects, the ANI/WG and the E/CAR/CATG and representatives of invited international organizations. The objectives of the NACC/WG are to analyze the activities to achieve regional performance targets and metrics, identify and monitor operational benefits from the NAM/CAR Regional Performance-Based Air Navigation Implementation Plan (NAM/CAR RPBANIP), promote regional coordination of Aviation System Block Upgrades (ASBU) B0 modules and, in general, to review, follow-up, and facilitate coordination and decisions for air navigation services and facilities implementation in the NAM/CAR Regions according to the ICAO Global Air Navigation Plan.

Simultaneous English-Spanish interpretation services will be provided. The Provisional Agenda for the meeting is shown in the **Appendix**. The confirmed venue and hotel information will be sent at a later date.
