I wish to invite your Administration/Organization to participate in the ICAO CAR/SAM electronic Terrain and Obstacles Data (eTOD) Seminar to be held at the ICAO NACC Regional Office, Mexico City, Mexico, 23 to 25 November 2015.

The Seminar refers to the Aeronautical Information Management (AIM) Regional Performance Objectives (RPOs) of the NAM/CAR Regional Performance-Based Air Navigation Implementation Plan (NAM/CAR RPBNIP); specifically, RPO 4 - *Improve Situational Awareness*, and implementation of ICAO Aviation System Block Upgrades (ASBUs) B0 module: B0-30/ AIM - *Safety and Efficiency of Surface Operations*.
