- Created in 1948 with 13 pilot associations making up the membership
- For pilots to have a voice at the newly-created agency of the United Nations

IFALPA'S MISSION



The mission of IFALPA is to be the global voice of airline pilots to promote the highest level of aviation safety world-wide and to provide representation, services and support to all of its Members Associations.

IFALPA'S CORE FUNCTIONS (1)



 Protect and enhance aviation safety to the highest standard by promoting a single level of safety world-wide.

 Develop common policies and positions and to promote the adoption of such policies by ICAO, regulatory authorities and the State of each Member Association.

IFALPA'S CORE FUNCTIONS (2)



 Promote and enhance the role of the airline pilot and other professions represented by Member Associations, e.g. flight engineer and helicopter pilot (hereinafter referred to as "airline pilot") in ensuring the safety and well being of passengers and goods entrusted to their care.

IFALPA'S CORE FUNCTIONS (3)



 Protect, promote and enhance the professional status of the airline pilot.

 Promote quality employment opportunities for airline pilots by supporting a viable and expanding air transport industry.

IFALPA'S CORE FUNCTIONS (4)



 Provide training and education for the benefit of airline pilots and assist in the organisational development of Member Associations.

 Facilitate the exchange of information and the coordination of activities amongst Member Associations and Pilot Alliances

IFALPA'S AIMS



- To develop and promote a common pilot viewpoint on:
 - Technical developments in aviation
 - Air safety objectives
 - International standards and regulations governing air transport operations
- To press for adoption of IFALPA policies in the State of each Association and ICAO

STRUCTURE OF IFALPA



- Annual Conference IFALPA's governing body
 - Attended by representatives of each Member Association, directs IFALPA's work
- Ten elected Executive Officers (Executive Board) oversee the work in between Conferences
- Full-time Secretariat carries out the associated administrative duties

ANNUAL CONFERENCE



- Hosted by a Member Association but organised and administrated from IFALPA Headquarters.
 - Members vote for future venues
 - o 2016– New Orleans 2017 Montreal
- 350 + delegate (pilot) attendees
 - o Family social programme
- Confirms IFALPA policy for coming year
- Endorses Committee Work Programmes
- Elects Officers

EXECUTIVE BOARD



- Oversees the work of the Federation between Conferences
- Meets formally several times each year
 - Meetings hosted by Member Associations
 - Individual Member Associations get to know the Executive Board
- Represents the Federation at high level meetings
