1.1 RASG-PA RSAs are issued to encourage States/Territories, international organizations and industry to adopt practices to mitigate the major aviation safety risks in the Pan American Region, as identified through the regional data analysis.

 - RSA-001: Mode Awareness and Energy State Management Aspects of Flight Deck Automation
 - o Required Action: Consider adoption of the subject RSA using the advisory circular on Mode Awareness and Energy State Management Aspects of Flight Deck Automation
 - RSA-002: Closing of Detailed Implementation Plans (DIPs)
 - Required Action: Adoption, as applicable, of the various Safety Enhancement Initiatives (SEIs) developed by RASG-PA
 - RSA-003: Closing of DIP RE/08 Guidance for Maintaining Runways in Accordance with ICAO Annex 14
 - Required Action: Adoption, as applicable, of the Safety Enhancement Initiative (SEI) Detailed Implementation Plan (DIP) RE/08 Guidance for Maintaining Runways in Accordance with ICAO Annex 14 developed by RASG-PA
 - RSA-004: Standardization of Spanish and English ATC Phraseology in Accordance with the ICAO PANS ATM (Doc 4444)
 - Required Action: Adoption, as applicable, of the Standardization of Spanish and English ATC Phraseology in Accordance with the ICAO PANS ATM (Doc 4444) developed by RASG-PA
 - RSA-005: Closing of DIP RE/09 Specific Training for Pilots and Air Traffic Controllers to Avoid Unstabilized Approaches
 - o Required Action: Take note
- 2.2 It is expected that States/Territories, international organizations and industry take advantage of the valuable work, regarding safety, carried out by some of the RASG-PA Members and published through the RSA as part of the RASG-PA safety promotion, and report any shortfall and/or barrier identified during the implementation of the SEIs delivered by RASG-PA.
- 2.4 It should be noted that RASG-PA is fulfilling the objective to enhance safety in the Pan American Region by reducing duplication of efforts, human and financial resources expenditures.
