In accordance with Conclusion ANI/WG/1/11 - Workshop on ATM, AIM And MET Coordination of the First NAM/CAR Air Navigation Implementation Working Group (ANI/WG/1) Meeting, Mexico City, Mexico, 29 July to 1 August 2013, I wish to invite your Administration/Organization to participate in the Meeting to enhance State Coordination between Aeronautical Meteorology (MET), Aeronautical Information Management (AIM), and Air Traffic Management (ATM) fields to be convened at the ICAO NACC Regional Office, Mexico City, Mexico, from 26 to 28 July 2016.
