I wish to invite your Administration/Organization to participate in the Workshop for the Implementation of Navigation Infrastructure to Support Performance-Based Navigation (PBN) and Global navigation satellite system (GNSS) Precision Approach Operations in the NAM/CAR/SAM Regions, to be held in Lima, Peru from 15 to 17 August 2016.

The workshop objective is to provide technical and operational information to the States, Air Navigation Service Providers (ANSP) and users for the effective implementation of the air navigation infrastructure to support PBN and GNSS precision approach operations.

The workshop is designed to support the implementation of Aviation System Block Upgrade (ASBU) B0 modules mainly: B065/APTA- Optimization of approach procedures including vertical guidance, B0-10/ FRTO Improved Operations through Enhanced En-Route Trajectories, B0-05/CDO: Improved Flexibility and Efficiency in Descent Profiles and B0-20/CCO Improved Flexibility and Efficiency in Departure Profiles - Continuous Climb Operations.

The workshop will consist of presentations by subject matter experts on navigation infrastructure of the States, industry and ICAO with wide experience in global and regional implementation, standards and documents of ICAO, current status and evolution of navigation infrastructure to support PBN and GNSS precision approach operations. Information on ionospheric and troposphere effects on GNSS and ground and flight testing considerations will also be presented.

This event is mainly oriented to authorities, planners and specialists in the management of air navigation systems, particularly on navigation systems, specialists in the installation, maintenance or operation of navigation systems, inspectors in flight pilots' navigation systems and maintenance personnel of commercial aviation.

Furthermore, in accordance with the 2016 Activities Plan approved by the Steering Committee of the Regional Technical Cooperation Project for the Caribbean Region – *Multi-Regional Civil Aviation Assistance Programme (MCAAP) (RLA/09/801)*, I am pleased to inform that the Project is offering for this event one fellowship to each Project Member<sup>1</sup>.

The fellowship includes Daily Subsistence Allowance (DSA) to cover lodging and per diem. Your Administration shall provide the candidate with the air ticket to/from Lima, Peru, and ensure that the candidate has the necessary travel documents, vaccinations, and visa prior to departure. The duly completed Fellowship Nomination Form must be received in this Regional Office by **25 July 2016**.
