Sir/Madam:

I wish to invite your Administration/Organization/Air Navigation Service Provider (ANSP) to participate in the International Civil Aviation Organization (ICAO)/International Air Transport Association (IATA)/Civil Air Navigation Services Organization (CANSO) Performance-Based Navigation (PBN) Harmonization, Modernization and Implementation Meeting for the Caribbean (CAR) Region, co-hosted by IATA in Miami, United States, from **28 March to 1 April 2016**.

As a result of work already accomplished at the March 2013 ICAO PBN Airspace Redesign Workshop, ICAO, IATA, and CANSO have jointly organized this meeting to assist the CAR Region in facilitating, coordinating, and harmonizing the PBN plans to align ANSPs, operators and States' civil aviation activities.

The meeting will focus its activities on harmonizing and finalizing a new PBN route structure for implementation, analysing regional implementation efforts, discussing best practices concerning Air Traffic Flow Management (ATFM), harmonizing cross route structures, enhance route efficiency and achieving agreement on implementation processes. Success will be measured by all States/Territories working together towards common goals in order to achieve safety and efficiency.

Participating representatives from your Administrations shall have the following expertise:

- ANSP representatives with decision-making responsibility
- Senior level managers/directors with decision-making authority over airspace matters
- ATM Managers with procedural and design experience, as well as intimate knowledge of local airspace matters, and certified on local air traffic operations

Each Administration represented should bring their PBN route proposals (as necessary, coordinated with adjacent FIRs) in order to begin the harmonization process of the entire upper airspace. At the end of this meeting, each Administration shall work out the final details of their PBN route proposals and activities for review, approval and implementation in accordance with the Regional CAR implementing action plan to be agreed upon at the meeting.

Additionally, during the course of the meeting, it is expected that Air Traffic Services (ATS) related matters within the ATS Letters of Agreement (LoAs) between adjacent FIRs will be discussed and reviewed to support future regional developments and to improve overall efficiency. States are kindly encouraged to conduct pre-coordination discussions on matters of mutual interest prior to the start of the meeting in order to complete the agenda activities.

The Provisional Agenda of the meeting will be distributed in early February 2016. The working language of the meeting will be English. There will be no interpretation service available.

You are kindly requested to complete and submit the Registration Form at **Attachment A** by e-mail for each participant by **5 February 2016**. In order to organize the logistic arrangements, your prompt response will be highly appreciated.

A list of hotels recommended for meeting participants is at **Attachment B**. Participants are encouraged to make reservations directly with the hotel(s) in a timely manner.
