The working languages of the meeting will be English and Spanish, and simultaneous interpretation will be provided if sufficient participants of both languages provide timely registration.

The deadline to receive papers is 8 September 2017. The deadlines for submission of documentation for translation will be strictly enforced. You are encouraged to submit documentation in both meeting languages (i.e., English and Spanish).

Agenda Item 2: Follow-up on Valid Conclusions and Decisions from NACC/DCA Meetings, Sub regional DCA Meetings and Regional Implementation Groups

Under this agenda item, the Meeting will conduct a follow-up review of valid conclusions and decisions of the NACC/DCA, and former subregional DCA meetings, highlighting the impact of these decisions and conclusions in the States' and Region's aviation safety, air navigation and security implementation. Moreover, the Meeting will be informed of the relevant conclusions that the NAM/CAR implementation groups are carrying out towards the development of the region's aviation activity.

Agenda Item 3: Global Implementation Updates

Under this agenda item, the Meeting will discuss the impact on States derived from a) results from 39th Session of the ICAO Assembly; and b) the latest updates on global safety, Air Navigation Services (ANS), security, and air transport issues.

Agenda Item 4: Accountability Report of the ICAO NACC No Country Left Behind (NCLB) Strategy

The Secretariat will provide its Annual Accountability Report 2016-2017 in accordance with the NACC NCLB Strategy, including but not limited to:

- 4. Status of Aerodrome Certification and Runway Safety Teams (RST)
- 5. Aviation Security (AVSEC) and Facilitation (FAL): Review of National Security Programmes and Aviation Security State Improvement Plan (SIPs)
- 6. ICAO outreach for government and non-government third parties funding to support State/region aviation development
- 7. NAM/CAR Regional Training Centres Association
