Sir/Madam,

I wish to invite your Administration/Organization to participate in the ADS-B Implementation and Regulation Meeting for the NAM/CAR/SAM Regions (ADS-B/LEG) to be convened at the ICAO NACC Regional Office, Mexico City, Mexico, from 26 to 30 November 2018. This meeting is composed of two parts:

On 26 November 2018, the NAM/CAR Surveillance Task Force (SURV/TF) and the Surveillance Task Forces from the SAM Region will meet with the objective to update the status of implementation of the ADS-B, status of the activities agreed during the last meeting held in Lima, Peru in November 2017, for radar data sharing and finally prepare for the issues to be developed in the second part of the Meeting. The working language of this meeting will only be **Spanish**.

From November 27 to 30 November 2018, the rest of the NAM/CAR/SAM ADS-B Implementation and Regulation Meeting will be conducted. This part of the Meeting has the objective to assist the States in the implementation of ADS-B in accordance with the established target with the Regional Performance Objectives (RPOs) of situational awareness (Module B0-ASUR and B0-SURF) specified in the NAM/CAR Regional Performance-Based Air Navigation Implementation Plan (RPBANIP) and the Air Navigation System Performance-Based Implementation Plan (PBIP) for the SAM Region, including the review of regulation matters for its implementation. The working languages from November 27 to 30 November 2018 will be **English** and **Spanish**, and simultaneous interpretation will be provided if sufficient participants of both languages provide timely registration.

The event is addressed to air navigation system planners specialized in the surveillance area in the technical (maintenance), operational and regulation development responsible staff, and to the members of the NAM/CAR Air Navigation Implementation Working Group Meeting (ANI/WG) Surveillance Task Force (SURV/TF) and Surveillance Task Forces from SAM Region, who participate in the regional implementation and Surveillance activities. In the same way, it is addressed to the International Organizations and the industry, which will provide the aircraft fleet status in the region and the future planning for its use, provide information about ADS-B data quality and considerations for ADS-B n.

Documentation that your Administration/Organization may wish to submit/present at the meeting should be forwarded to this office by e-mail by **9 November 2018**, in Microsoft Word format using the attached templates. Working papers should be brief, action-oriented, and focused with a four-page limit excluding any appendices.

Only working papers received by this office by 25 October 2018, submitted by States/Territories, will be translated to ensure timely processing. Working papers received in this office after that date will have to be submitted in both languages and will be presented according to the availability of the work agenda. Otherwise, they will become Information Papers. Information papers will only be issued in the language submitted. Papers received from international organizations will not be translated and will be issued only in the language submitted. The deadline to receive papers is 9 November 2018. The deadlines for submission of documentation for translation will be strictly enforced. You are encouraged to submit documentation in both meeting languages (i.e., English and Spanish).

Furthermore, I am pleased to inform that each Project RLA/09/801 Member¹ may apply for a fellowship under Project RLA/09/801 within the fellowship offer for the current year. In order to know how many fellowships are available for your Administration for this year, please contact Ms. Claudia López, Technical Cooperation Associate (clopez@icao.int). The fellowship includes Daily Subsistence Allowance (DSA) to cover lodging and per diem. Your Administration shall provide the candidate with the air ticket to/from Mexico City, Mexico, and ensure that the candidate has the necessary travel documents, vaccinations, and visa prior to departure. The duly completed Fellowship Nomination Form must be received in this Regional Office by **29 October 2018**.
