1. Introduction

1.1 The Third NAM/CAR Civil Aviation Training Centres Working Group Meeting (NAM/CAR/CATC/WG/3) reviewed the status of valid Conclusions and Decisions and decided to complete their status considering that many of them were not up to date and other activities have been considered by ICAO GAT.

1.2 For the reference of the Meeting, the NAM/CAR Civil Aviation Training Centres Working Group (NAM/CAR/CATC/WG) records its activities as Draft Conclusions and Decisions as follows:

Draft

Conclusions: Activities requiring endorsement by the Directors of Civil Aviation of North

America, Central America and Caribbean (NACC/DCA).

Decisions: Internal activities of the NAM/CAR Civil Aviation Training Centres Working

Group (NAM/CAR/CATC/WG).

- 1.3 The status and follow-up remarks for Draft Conclusions and Decision is the result of a review by the Secretariat based on information available. The status for each Conclusion and Decision is designated as valid, completed or superseded.
- 1.4 This working paper presents in **Appendix A** the conclusions and decisions valid from the Third NAM/CAR Civil Aviation Training Centres Working Group Meeting (NAM/CAR/CATC/WG/3).
- 1.5 Likewise, this working paper presents in **Appendix B**, for information of the meeting, the conclusions related with training matters from previous meetings of North American, Central American and Caribbean Directors of Civil Aviation.
- 1.6 The Secretariat has carried out an assessment of the actions and follow-up carried out by this group since its first meeting, identifying that the tasks and goals that were established from the first meeting have not been complied with and that, since the last NAM/CAR/CATC/WG/3 meeting, all these conclusions were completed without any apparent action. **Appendix C** to this paper presents this assessment.
- 1.7 Each training centre should pose the following questions to themselves in order to promote each centre, as well as the work of the NAM/CAR/CATC/WG in order to obtain regional benefits:
 - Periodic Promotion of each center's training offer
 - What are the main goals of each center and how we can the NAM/CAR/CATC/WG help to promote them
 - Is each Center performance and planning based on results considering the needs of the regions or the States?
 - What is each Center's commitment to support the Regions' training needs

 - a) review and take action on the conclusions and decisions contained in the Appendixes;
