I wish to invite your Administration/Organization to save the date for the CAR/SAM Risk-based Surveillance (RBS) Workshop to be convened in Lima, Peru, from 19 to 20 March 2018. The workshop supports the initiative agreed under Conclusion NACC/DCA/7/6 *NACC State Safety Programme (SSP) Implementation Strategy* on a Regional CAR SSP implementation strategy linking all existing safety oversight implementation initiatives, and using the champion States concept to provide practical assistance, allowing SSP implementation based on the experience of States that have already been able to develop meaningful experience in the subject.

This Workshop will allow participants to identify the link between the RBS methodology and the State Safety Programme (SSP), the process and procedures for the implementation and application of the RBS, as well as the opportunities for the optimization of the use of resources by States. Organizations and States that are presently leading the global RBS implementation will share their experiences and lessons learned.

The workshop is addressed to the Flight Safety Directors, and personnel responsible for the SSP implementation in each State of the CAR/SAM regions. Likewise, the workshop is of relevant interest to the Accident and Incident Investigation Authorities, which are key for the establishment and operation of an SSP. The working languages of the workshop will be English and Spanish, and simultaneous interpretation will be provided if sufficient participants of both languages provide timely registration.

Please take note that this event will take place the following week to the Regional Safety Management Symposium and Workshop (Lima, Peru, 13-16 March 2018).


