Agenda item 1: Status of implementation of automated protocols

Under this Agenda item, States will monitor the implementation status and operational performance of the AIDC. The measures and mechanisms for monitoring and evaluating the regional implementation will be provided and the scheduled activities will be monitored by the AIDC Task Force of the NAM/CAR region.

Agenda item 2: Implementation Process of the pending AIDC in the NAM / CAR Regions

The Meeting will review the status of regional implementation and will support the implementation of the States that recently installed new ATC systems, with the objective of helping them in this process and supporting regional interconnection.

Agenda item 3: Air traffic control (ATC) systems database configuration and maintenance process

Under this Agenda item, the Meeting will analyse the failures in the AIDC due to the lack of a correct configuration and the lack of updates of the ATC Systems databases. The Industry will be invited to provide recommendations and best practices for the correct configuration of these databases.

Agenda item 4: Analysis of the availability and errors of flight plans in the NAM/CAR/SAM Regions

The Meeting will receive information on the concept of flight information, the flaws in the information of flight plans and the mechanisms implemented to minimize errors in flight plans. The Agenda will be guided by the analysis information provided by the AIDC Task Force.

Agenda item 5: Update and maintenance process of Aeronautical addressing of AMHS Systems (Aeronautical message handling system)

Under this item, the Meeting will receive information provided by Eurocontrol, corresponding to the Aeronautical Mobile Communications (AMC) area. In this regard, States will have the opportunity to review and update the mechanisms for updating the aeronautical addressing data of their AMHS systems, and to assign the personnel who will be responsible for updating AMHS systems in the future.

In response to the information presented at the meeting, the AIDC Task Force will update the status of the activities to be carried out during the year 2019, in order to ensure a correct and effective implementation.
