1. Introduction

- 1.1 On 28 December 2018, the ICAO General Secretariat sent a State Letter inviting States to the 40th Session of the Assembly of ICAO, which will be held in Montréal from 24 September to 4 October 2019
- 1.2 ICAO's 193 Member States and a large number of international organizations are invited to the Assembly, which establishes the worldwide policy of the Organization for the upcoming triennium. During Assembly Sessions, ICAO's complete work programme in the technical, economic, legal and technical cooperation fields is reviewed in detail. Assembly outcomes are then provided to the other bodies of ICAO and to its Member States in order to guide their continuing and future work, as prescribed in Article 49 of the Convention on International Civil Aviation
- 1.3 Considering the importance of State's participation at the aforementioned event, the Eighth Meeting of the North American, Central American and Caribbean Directors of Civil Aviation (NACC/DCA/08) held in Ottawa, Canada, from 31 July to 2 August 2018, agreed on the following conclusion:
