General information

San Salvador is the capital of the Republic of El Salvador and one of the 14 departments that make up the country. It is located in the central area of the country and its altitude is between 600 and 1000 meters above sea level.

Its geographical division is composed of 19 municipalities that are: Aguilares, Apopa, Ayutuxtepeque, Cuscatancingo, Ciudad Delgado, El Paisnal, Guzapa, Mejicanos, Nejapa, Panchimalco, Rosario de Mora, San Marcos, San Martin, San Salvador, Santiago Texacuangos, Santo Tomás, Soyapango, Tonacatepeque and Ilopango. The latter is where the Central American Institute for Aeronautical Training (ICCAE) is located.

Weather

El Salvador is located in the tropical climatic zone, whose thermal conditions remain similar throughout the year. It is located in the coastal strip of the Pacific Ocean and, therefore, it has important annual oscillations, due to the sea breeze that carries moisture and heat.

The typical climate of the country is dry and humid tropical. It has two seasons: the rainy season (between May and October) and the second, the dry season (which occurs between November and April). However, among its characteristics there is its natural beauty, marked by mountains where you can enjoy a cool climate.
