1. Introduction

1.1 The Sixth Meeting of the North American, Central American and Caribbean Directors of Civil Aviation agreed the Rotational Scheme for States and Territories hosting the NACC/DCA meetings as per:

**CONSOLIDATION OF SUB-REGIONAL DIRECTORS OF CIVIL AVIATION
(DCA) MEETINGS**

That, in order to gain efficiency, effectiveness and obtain more active participation of the NAM/CAR DCAs, the NAM/CAR States agree the consolidation of all the sub-regional DCA Meetings into a single annual DCA Meeting as NACC/DCA Meetings, approving its terms of Reference and Rotation Meeting scheme as shown in Appendix E.

1.2 In accordance with the Terms of Reference agreed during the NACC/DCA/07 meeting, (Appendix C to the report refers), the NACC/DCA meets as per the following rotational scheme: Central America, North America, Eastern Caribbean and Central Caribbean.

2. Discussion

2.1 During the NACC/DCA/08 meeting, Trinidad and Tobago kindly offered to host the NACC/DCA/9 meeting.

2.2 The next area to host the NACC/DCA meeting should be the Central Caribbean. However, any other State may propose to be the host.

3. Suggested Action

3.1 In view of the information presented above, the delegates of the C/CAR States/Territories are invited to propose the venue for the next NACC/DCA meeting.
