I wish to invite your Administration/Organization to participate in the ICAO/IATA Security Management Systems (SeMS) Awareness Workshop to be convened at the North American, Central American and Caribbean (NACC) Regional Office in Mexico City, Mexico, from 1 to 3 October 2019.

ICAO will host this Workshop delivered by the IATA Regional Security Focus Group, free of charge for ICAO States and with the participation of subject matter experts from the NAM and CAR Regions.

The workshop is aimed at all industry partners, particularly individuals who have a security responsibility at airlines, government authorities, airports and third-party contractors. It will showcase how the airline SeMS principles and benefits can be adapted and applied across the industry.

A greater awareness and promotion of SeMS principles was identified by ICAO and the IATA Regional Security Focus Group as a key priority in the region. ICAO's Global Aviation Security Plan (GASeP) and the ICAO NAM/CAR/SAM Regional Roadmap for implementation of GASeP recognizes SeMS as a means to meet current and future aviation stakeholder responsibilities.

SeMS encourage a business-like approach to security, based on the proven principles of the airline's Safety Management System (SMS). Topics covered will include:

- ICAO GASeP and ICAO Standards and Recommended Practices (SARPs)
- Senior management and corporate commitment
- Resources Management
- Threat assessment and risk management
- Management of emergencies and incidence
- Quality control and quality assurance
