Sir/Madam,

Regional implementation of AIDC and NAM/IDC automated protocols is a high priority due that they seek to increase efficiency of regional operations and, at the same time, safety.

For this reason, the Third NAM/CAR Air Traffic Services Inter-facility Data Communication (AIDC) and North American Interface Control Document (NAM/IDC) Implementation Follow-up Meeting will be held in Mexico City, Mexico, from 25 to 28 February 2020.

The objective of the meeting is to follow-up previous AIDC Meetings and the activities agreed by the States for the national and regional implementation through:

- 1. follow-up of the measures to optimize flight plans management and aeronautical information management to minimize errors in flight plans (FLP, jointly with the Aeronautical Information Management (AIM) implementation Task Force, part of the Air Navigation Implementation Working Group (ANI/WG);
- review and follow-up of the regional AIDC implementation action plan;
- 3. align the regional Action Plan activities with the NACC regional objectives and with the new version of the Global Air Navigation Plan;
- agree on the necessary actions to ensure a successful regional implementation of the regional AIDC and NAM/ICD protocols; and
- update the work plan of the ANI/WG AIDC implementation Task Force.

The participant experts profile is very important to reach the regional automation goals considering that they will provide the recommendations needed to allow the effective operational implementation of both protocols. In this sense, the participation of personnel responsible for the AIDC and NAM/ICD implementation projects is highly recommended. Furthermore, the participation of members of the ANI/WG AIDC Task Force is expected. The industry is also invited to present its lessons learnt of the latest implementations carried out in the Caribbean (CAR) Region.

It is important to note that the first day of the meeting will be carried out jointly with the participants of the AIM Task Force Meeting with the objective of analysing the results of the statistical analysis of the flight plans errors and their impact on the AIDC operation, and to review the impact of the AIM data exchange implementation in the automatized operations in the region.

The working language of the event will be **English.** However, only on 25 February 2020, when the joint Meeting is carried out, simultaneous interpretation services will be provided to facilitate the discussion of Agenda Item 2.

It is expected that, as a result of the first-day joint meeting, the training profile of the aeronautical information service/air traffic services reporting office (AIS/ARO) personnel will be updated and tasks in the ANI/WG AIM Task Force that ensure aeronautical information quality and its positive impact on the AIDC implementation will be integrated.
