We invite you to participate in the **Second NAM/CAR and SAM OACI/CLAC (AVSEC/FAL/RG/VM/Ex02) Regional Group Extraordinary Virtual Meeting**, to be held via Zoom on Thursday, 24 September 2020, at 10:00 hours (UCT-05:00). The meeting will count with simultaneous interpretation services (English-Spanish).

As agreed during the first virtual meeting of this Regional Group, held on 28 May 2020, it is intended that the AVSEC/FAL/RG meets regularly to address issues of interest, until it is possible to carry out a face-to-face meeting. As you know, the Tenth Meeting of this group was planned in March 2020 in Foz de Iguazu, Brazil, but it was postponed due to the COVID-19 pandemics.

One of the purposes of this virtual meeting is to analyse the information sent by the States regarding the measures that have been implemented at the points of entry to avoid the spread of COVID-19, and to develop a list of best practices for the NAM/CAR and SAM Regions, and new provisions established by the ICAO Council to follow up counter measures implemented to prevent COVID-19 pandemic in the international air transport operations.
