
BACKGROUND

En los últimos años el GREPECAS ha definido una cantidad considerable de Programas/Proyectos, a los cuales no se ha dado un adecuado seguimiento para obtener los resultados esperados, ni se ha medido la utilidad de estos. tamogoc el impacto que tienen en los obletivos estratégicos de la Organización.

Hemos visto además, que una gran parte de los Programas / Proyectos son de cumplimiento, es decir, para cumplir con algún requisito normativo y dejar evidenciado el proceso en lugar de establecer la efectividad que sume valor a los planes estratégicos trazados por la Organización de Aviación Civil Internacional (OACI) tal y como lo establecen los principios que dan objeto al Grupo.

Se observan con frecuencia las actividades de implementación de alguna iniciativa, sin ser tomados en cuenta los objetivos organizacionales, que muchas veces están incluidos en el proyecto sin aportar otro servicio, al cual ellos están comprometidos.

Aun cuando el Grupo ha asignado orgánicamente el seguimiento o la coordinación de los Programas a los Oficiales Regionales de cada área y siguen las actividades descritas en los RBO's (Objetivos de Desempeño Regional, por sus siglas en ingles), se carece de un protocolo efectivo para identificar necesidades emergentes y clasificar de manera adecuada esta herramienta, además de no contar con una metodología eficaz de medición, así como de la información y el seguimiento una permita cuantificar los resultados alcanzados.

Esta situación plantea algunas dudas cuyas respuestas intentaremos encontrar en el desarrollo de este proyecto. Estas son:

- Están los proyectos establecidos por los Estados alineados a los proyectos estratégicos regionales y estos a su vez a los objetivos estratégicos de la organización y estos a su vez a los planes estratégicos trazados por la OACI?
- ★ ¿Se han cumplido los obietivos de los Programas y Proyectos realizados?

The GREPECAS Chairman created a Draft ver. 1.0, High-level document presented in July 2019

It raise issues to resolve, such as:

- 1. Are the projects established by the States aligned to the regional strategic projects and these in turn to the strategic objectives of the organization and these in turn to the strategic plans drawn up by ICAO (GANP)?
- 2. Have the objectives of the Programs and Projects carried out been met?
- 3. How is the need for one or the other determined?
- 4. What follow-up is given to them?
- 5. At what point should they be updated or closed?

Preliminary project

Three Project Phases

- 1. In the first, the concepts that support the central theme are clarified, establishing the current situation and the effects on the results.
- 2. The second phase consists of an analysis of the status of the Group's current situation in handling the issue, as well as a brief diagnosis.
- 3. In the third phase, an action plan is drawn up to define the methodology, and guidelines for systematized measurement are given, where the indicators that measure the efficiency of the final product are defined.

Identified as the main improvement:

The creation of a proactive Automated Management system to follow up on regional programmes and projects in a timely and effective manner, which is what would lead us to obtain the measurement, monitoring and control necessary to achieve strategic goals and objectives and the desired impact on the States of the Region.

Improvement Goals



INITIAL GOALS

Goal 1) Increase by 15% annually the percentage of effective implementation of the projects proposed in the Working Groups, by 2020.

Goal 2) Link the needs of the NACC-SAM Member States with the implementation projects of the Region, contributing 15% to the initiative by 2021, through training of Human Resources.

Goal 3) Establish 90% effective work methodology, which guarantees the continuity of the works and the fulfillment of the goals of the period and future ones.

Goal 4) Establish a program of exchange of good practices between the States, based on the objectives of the GANP and GASP, through the implementation projects of GREPECAS and RASG-PA.

GREPECAS the next step

- ★ Assist States identifying the most appropriate operational improvements even though the COVID-19 affected most of Air Navigation Systems
- ★ GREPECAS will support States to assess changes in air traffic and ensure the provision of security and optimal air navigation services (ANS), which have decreased due to a reduction in passenger demand and travel restrictions imposed by States as a result of the pandemic COVID-19 that continues to cause serious public health concerns
- ★ GREPECAS could help the States of CAR/SAM Regions to evaluate and seek alternative solutions to the forecasts that expect a further decrease in air traffic in the short term due to additional economic measures.
