


Guiding Principles

Framework	Canada's Flight Plan for Navigating COVID-19	August 14, 2020	Canada's Flight Plan is the foundation for Canada's current and future efforts to reduce the public health risks of COVID-19 while travelling by aircraft. It demonstrates that Canada has in place a multi-layered system of safety measures to support public health, in order to protect air travellers and air industry workers from COVID-19.
Legislative Measures	Interim Order Respecting Certain Requirements for Civil Aviation Due to COVID-19, No. 10	October 8, 2020	Interim Order under the authority of the <i>Aeronautics Act</i> that includes temporary requirements on the aviation industry and air passengers related to: <ul style="list-style-type: none"> • Wearing of face coverings • Temperature screening • Health checks • Notification of passengers regarding quarantine requirements • Denial of boarding to those ineligible to enter Canada during the pandemic.
Regulatory Measures	Interim changes to the AME licence application and approval procedures during the COVID-19 pandemic	April 24, 2020	This notice is to provide information on the interim changes to the acceptance of documents sent via email in support of an AME application, and to the validity of AME application forms and approvals to attempt the Transport Canada Civil Aviation (TCCA) examinations.
	COVID-19-Related Regulatory Exemptions	N/A	Web page with all Transport Canada issued regulatory exemptions in response to the COVID-19 pandemic.
	Transport Canada Temperature Screening Standards	October 9, 2020	This document defines the technical standards and processes for the use of temperature screening equipment for the <i>Interim Order Respecting Certain Requirements for Civil Aviation Due to COVID-19, No. 10</i> (Interim Order).
Guidance	Environmental sanitation practices to control the spread of communicable disease in passenger conveyances and terminals	September 17, 2019 (letter specific to COVID-19 dated March 9, 2020 and published by ICAO)	Guidance provided by the Public Health Agency of Canada's Travelling Public Program to assist conveyances and terminal operators in determining appropriate infection control measures to be used onboard a passenger conveyance or in a terminal.

Voluntary Procedures	Model Standard Operating Procedures Facilitating the Exposure Notification and Contact Tracing of Air Passengers and Data Exchange	September 11, 2020	Standard operating procedures which can be adapted by air operators and public health authorities to manage the collection, exchange and disposal of passenger information for the purpose of facilitating the exposure notification and contact tracing of passengers sitting near an individual who has recently flown on a domestic flight and has tested positive for COVID-19.
Safety Alerts and Bulletins	Safety Alerts and Bulletins	N/A	Web page with all Transport Canada-issued safety bulletins and alerts in response to the COVID-19 pandemic.
