## Global Aviation Training

Established operational efficiencies to:

1. Identify priority training needs, in consultation with Technical Bureaus and Regional Offices (i.e. COVID-19 related training needs).
2. Leverage from ICAO subject matter expertise to develop adapted & competency-based training that meet the priority needs of the industry (i.e. increasing virtual and online training in light of COVID-19).
3. Deliver ICAO training to a high volume audience to support ICAO priorities (i.e. through the TRAINAIR PLUS Network composed of 100+ training organization belonging to CAAs, ANSPs, Airports or Operators).

## Actual COVID -19 Activities Undertaken by TCB

### Procurement

Long term Agreements with Suppliers for urgent COVID-19 related equipment, such as:

- disinfection equipment
- thermal cams (fix and mobile)
- transparent tents (Airport and aircrafts)
- negative pressure rooms for the complete isolation for patients
- Detection kits
- Etc...

### Implementation Packages being considered:

- National crisis management plans for direct action on communicable disease outbreaks
- Establishing aerodrome emergency plans for public health emergencies of international concern
- Conducting aviation safety risk assessments during a public health crisis in aviation
- Establish succinct guidance for licencing issues related to the restart
