<b>EXECUTIVE SUMMARY</b>	
This Working Paper presents the proposal for a project to support SAR implementation in the CAR/SAM Regions, as an interregional collaboration and work initiative for the implementation of Search and Rescue (SAR) services in the CAR/SAM Regions.

**1. Introduction**

1.1 Search and Rescue (SAR) services constitute an essential part of Air Navigation Services (ANS), reflected as part of the commitments of the Contracting States of the Chicago Convention.

1.2 The proper establishment of SAR services represents an important means of protecting the lives of those who use aviation as a means of transportation. Additionally, the availability of SAR resources often provides a critical initial response and life-saving relief capability in the early stages of a natural or man-made disaster. Therefore, SAR services are sometimes part of a local, national or regional emergency management system.

## 2. Background

2.1 The CAR/SAM Regional Planning and Execution Group (GREPECAS) is responsible for the development and maintenance of air navigation plans and provides for the planning and implementation of air navigation systems within specific areas, in accordance with the planning frameworks agreed at global and regional level.

2.2 The GREPECAS is the guidance and coordination body for all activities carried out by ICAO in relation to the air navigation system for the CAR/SAM Regions and its activities are subject to review by the ICAO Council. In other words, it is through GREPECAS that the ICAO Council is informed about the development and implementation of specific issues for air navigation, as well as the regional and emerging air navigation challenges experienced that affect the implementation of the provisions. ICAO Global Guidelines by States and the measures taken or recommended to address them effectively.

2.3 GREPECAS/19/04 Conclusion instructed the ICAO NACC and SAM Regional Offices to evaluate the current challenges regarding the provision of SAR services in the CAR/SAM Regions, identify opportunities for improvement in order to promote the joint work of the SAR between the CAR/SAM Regions and develop a Project proposal that supports SAR activities, for consideration by GREPECAS at the GREPECAS/20 Meeting.

## 3. Analysis

3.1 The CAR/SAM Regions have experienced significant growth in the flow of operations, as well as in infrastructure and support services for air navigation. Eventually, this expansion has not seen in the provision of SAR services an attention comparable to that of other areas of air navigation.

3.2 In addition, the activities of the Regional Offices for assistance and monitoring of the implementation of SAR services have been significantly reduced in recent years. The support of the States for the participation of their SAR experts has been diminished, leaving very few fora available in which the main issues concerning this service can be discussed, as well as the development of joint collaboration and integration strategies.

3.3 The CAR and SAM Regions have their implementation mechanisms for air navigation, which attend to the implementation of SAR services, separately. GREPECAS would be the ideal means to promote the harmonization of the CAR/SAM Regions in SAR matters.

## 4. Conclusions

4.1 The Search and Rescue Task Force (SAR/TF) of the North American, Central American and Caribbean Working Group (NACC/WG) considered that interregional linkage with the SAM Region would be a necessity, due to the nature of SAR provision.

4.2 The approval of a SAR project in GREPECAS will enable greater visibility and support for related activities, communicating more objectively to the ICAO Council the progress of SAR implementation in the CAR/SAM Regions. In the same sense, a higher level support will be promoted to meet the signing of SAR agreements. The SAR project proposal is presented in the **Appendix** to this working paper.

**5. Suggested actions**

5.1 The Meeting is invited to:

- a) support the conclusions shown in section 4;
  - b) request GREPECAS consensus on the project proposal found in the Appendix, so that it can be submitted for approval by the Programmes and Projects Review Committee(PPRC); and
  - c) take any additional action deemed necessary.
