

## Overview of ICAO assembly

The Organization's sovereign body which establishes the worldwide policy of the Organization for the upcoming triennium.

Reviews in detail the work of the Organization in the technical, administrative, economic, legal and technical cooperation fields.

Approves the triennial budget and elects the Council.

## Overview of ICAO Assembly

The ICAO Assembly is the Organization's sovereign body. It meets at least once every three years and is convened by ICAO's governing body, the Council.

ICAO's 193 Member States and a large number of international organizations are invited to the Assembly, which establishes the worldwide policy of the Organization for the upcoming triennium.

## Overview of ICAO Assembly

**During Assembly Sessions, ICAO's complete work programme in the technical, economic, legal and technical cooperation fields is reviewed in detail. Assembly outcomes are then provided to the other bodies of ICAO and to its Member States in order to guide their continuing and future work, as prescribed in Article 49 of the Convention on International Civil Aviation.**

**Each Member State is entitled to one vote on matters before the Assembly, and decisions at these Sessions are taken by a majority of the votes – except where otherwise provided for in the Convention.**

# Guidelines for the Preparation of Working Papers and Deadlines for Submission

All submitted documentation (working papers/information papers) must be formatted in accordance with the templates

Working papers must be brief, action-oriented and concise, and must adhere to a strict four-page limit for text.

Working papers and information papers from Member States and International Organizations will be considered final on submission to the Secretariat and no revisions will be accepted.



# Guidelines for the Preparation of Working Papers and Deadlines for Submission



**2 August 2022**

Working papers must be received by the ICAO Secretariat by the deadline. All working papers/statements received after this date will not be translated and will be posted as information papers in the language(s) received. No revisions will be accepted.



**13 September 2022**

Information papers must be received by the ICAO Secretariat by the deadline. ICAO does not provide translation for information papers, which are posted in the language(s) of submission. These papers are NOT intended to be considered by the Assembly. No publishing of information papers received after this date. No revisions of information papers will be accepted.



# Guidelines for the Preparation of Working Papers and Deadlines for Submission



No translation service is provided for working papers submitted by International Organizations, whose working papers must be submitted in all six language versions by the cutoff date. In case of a missing language, the working paper will be classified as an information paper and the International Organization will be informed accordingly.

The papers will be published non-simultaneously: both the original submissions and the English versions will be published first, followed by the other language versions as soon as they are available.
