

The Secretariat will inform on relevant considerations of LACAC to the work of the Regional Group for its consideration and action. Likewise, the Meeting will be informed of the most critical compliance issues observed in the Universal Security Audit Programme (USAP) audits in the NACC and SAM Regions, with a view to a discussion for support and follow-up actions for the States to improve their Effective Implementation (EI). The Secretariat will present the AVSEC and FAL assistance activities in each of the NACC and SAM Regions.

Agenda item 3

Under this agenda item, and in response to Conclusion AVSEC/FAL/RG/10/03 on the need to have a better definition of the objectives of the AVSEC/FAL/RG, the proposal to update the Terms of Reference (ToRs), prepared by the Ad-hoc Group, will be presented.

Likewise, a proposal for procedures of the AVSEC/FAL/RG work programme will be presented.

Agenda item 4

The progress achieved in the projects and initiatives aimed at: improving the effectiveness of the facilitation committees, evaluation of didactic material for a facilitation instructor training course, progress of the project for passengers with disabilities and proposal for awareness and follow-up of the ICAO Traveller Identification Programme (TRIP) Roadmap in the region to quantify progress on Facilitation; works related to the Key Performance Indicators (KPIs), and the electronic passport (ePassport), among others will be presented.

The Meeting will provide information on projects and initiatives in AVSEC, including the implementation of regional projects for the introduction of One-Stop-Security (OSS). The contributions of the States for the implementation of OSS will also be discussed, with the supervision of the coordinating States. During the summer (July to September), the maximum temperature is around 32°C (89.6 °F) at noon and the lowest is 23°C (73.4 °F) at dawn, dropping to 19°C (66.2 °F) in winter (December to March), while in the mountainous areas of Jarabacoa and Constanza, it usually drops to around 5°C (41°F).
