EXECUTIVE SUMMARY

This Working Paper provides information regarding the approved GREPECAS project to support SAR implementation in the CAR/SAM Regions and propose actions to integrate the related activities to the NACC/WG/SAR/Task Force Work Programme.

1. Introduction

1.1 Search and Rescue (SAR) services constitute an essential part of Air Navigation Services (ANS), reflected as part of the commitments of the Contracting States of the Chicago Convention.

1.2 The proper establishment of SAR services represents an important means of protecting the lives of those who use aviation as a means of transportation. Additionally, the availability of SAR resources often provides a critical initial response and life-saving relief capability in the early stages of a natural or man-made disaster. Therefore, SAR services are sometimes part of a local, national, or regional emergency management system.

2. Background

2.1 For several years, the regional initiatives to support the implementation of search and rescue services in the CAR Region have been facing significant challenges in order to maintain themselves.

2.2 The lack of support and adequate representation in the meetings organized by ICAO had caused these activities to be discontinued, causing a lag in regional support for SAR implementation.

2.3 Since 2017 the ICAO NACC Regional Office started the implementation of a renewed SAR support strategy, which allowed the approval of the CAR Region SAR Plan, the establishment of the NACC Working Group SAR Implementation Task Force and the convening of annual follow-up SAR meetings.

3. Analysis

3.1 Despite the aforementioned activities, the link with the South American Region was still pending, as well as the report of SAR activities to the ICAO Council.

3.2 The GREPECAS is the guidance and coordination body for all activities carried out by ICAO in relation to the air navigation system for the CAR/SAM Regions and its activities are subject to review by the ICAO Council. In other words, it is through GREPECAS that the ICAO Council is informed about the development and implementation of specific issues for air navigation, as well as the regional and emerging air navigation challenges experienced that affect the implementation of the provisions. ICAO Global Guidelines by States and the measures taken or recommended to address them effectively.

3.3 GREPECAS/19/04 Conclusion instructed the ICAO NACC and SAM Regional Offices to evaluate the current challenges regarding the provision of SAR services in the CAR/SAM Regions, identify opportunities for improvement in order to promote the joint work of the SAR between the CAR/SAM Regions and develop a Project proposal that supports SAR activities, for consideration by GREPECAS at the GREPECAS/20 Meeting.

3.4 After consultation with the corresponding SAR coordination groups for both the CAR and SAM Regions, the Secretariat presented at the GREPECAS/20 Meeting (Salvador, Brazil, 16 – 18 November 2022) a proposal for a SAR Implementation Project for the CAR/SAM Regions, to streamline SAR implementation act and harmonize the support for CAR and SAM activities.

3.5 Through Decision GREPECAS/20/02 the SAR Implementation Project for the CAR and SAM Regions was approved to enable greater visibility and support for related activities, communicating to the ICAO Council more objectively the progress of SAR implementation in the CAR/SAM Regions. The approved project is presented as an **Appendix** to this Working Paper.

4. Conclusions

4.1 The CAR and SAM Regions have their implementation mechanisms for air navigation, which serve the implementation of SAR services, separately.

4.2 In order to comply with the activities approved in this project, the NACC/WG/SAR Implementation Task Force needs to integrate the GREPECAS project activities and deliverables into its own work programme, to ensure compliance with the GREPECAS mandate.

5. Suggested actions

5.1 The Meeting is invited to:
