Agenda Item 1: Adoption of the Provisional Agenda and Schedule

Under this agenda item, the Meeting shall review the agenda and schedule, and adopt them. The objectives and overall expectations of the meeting will be presented.

Agenda Item 2: Global Air Navigation Plan (GANP), seventh edition

Under this agenda item, the new edition of the Global Air Navigation Plan (GANP) Seventh Edition, the new version of the Basic Building Blocks (BBB) and their impact on the level of regional implementation will be evaluated.

Agenda Item 3: Correlation between the Implementation of Air Navigation and the Global Aviation Safety Plan (GASP)

The Meeting will revise the transversality of the Implementation of Air Navigation and Safety for the establishment of coordinated programmes. In addition, within this item on the agenda, the results of the 41st Session of the ICAO Assembly and its impact on the region will be evaluated, as well as the conclusions and decisions of the Twentieth Meeting of the GREPECAS (GREPECAS/20).

Agenda Item 4: Development of the Electronic Air Navigation Plan (e-ANP) Vol. III: regional objectives and metrics

In accordance with the above issues, work will be done on the necessary information for the development of the e-ANP Vol. III, the related tasks of each Task Group, the identification of regional objectives and the definition of regional measurement mechanisms for implementation.

Agenda Item 5: Update of the Action Plans of the Task Groups of the North American, Central American and Caribbean Working Group (NACC/WG), of the NACC/WG Action Plan and of the Regional Activities in the Development of the Projects of the CAR/SAM Regional Planning and Implementation Group (GREPECAS/20) (GREPECAS)

Each Task Group must update its action plan, which will be integrated into a single action plan for the NACC/WG with the identification of activities, deadlines and responsible parties; in the same way, work will be done on the correlation between these activities and/or the development of the work of the GREPECAS Projects.

In this sense, each rapporteur will be responsible for updating their work plan and coordinating joint activities that will be reflected in the final programme of the NACC/WG.

Any other issue that could not be addressed within the preceding issues will be analysed under this item on the agenda.
